Every reasonable effort will be made to clean up messes made by the client's pets that are found by the pet sitter.

_____The pet sitter will not be held liable for any sickness, injury, loss, or death of client's pets through non-negligence of pet sitter. The sitter will follow the directions of the Veterinary instruction and release form for pets that become sick or injured.

_____The pet sitter will not be held liable for plants, trees, and lawns that wilt, brown, or die to conditions beyond the directions supplied by the client. Watering of plants will be accomplished only in a manner client has so directed.
