BYLAW NO 2021-01

A BYLAW OF THE TOWN OF SPRINGSIDE TO FIX THE WATER, SEWER, GARBAGE AND RECYCLING UTILITY RATES

The Council of the Town of Springside in the Province of Saskatchewan enacts as follows:

- 1. This bylaw shall be known as the "Utility Rate Bylaw".
- 2. All persons desiring to be supplied with water from the Town of Springside's water supply shall make application to the officials of the Town. Any application for service in the name of any person other than that of the landowner shall pay a meter deposit as set out in SCHEDULE A attached.
- 3. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in SCHEDULE B attached; provided however, that the minimum shall be payable in every case whether or not any water is consumed.
- 4. Persons or entities who own or occupy premises drained or that are by bylaw required to be drained into the Town of Springside's sewer system shall pay for such services in accordance with SCHEDULE C attached or as amended from time to time.
- 5. Accounts for utilities shall cover a period of three successive months (QUARTERLY) and shall be paid within a period of thirty (30) days from the billing date. Accounts showing arrears sixty (60) days following each billing date will be disconnected subject to general provisions in the Water and Sewer Services Management Bylaw.
- 6. All properties that have a residential or commercial occupancy will be subject to the quarterly garbage collection fee as stipulated in SCHEDULE D. If a residential or commercial occupancy requests a second roll out garbage cart the fee will be as stipulated in SCHEDULE D.
- 7. All properties that have a residential or commercial occupancy will be subject to the quarterly recycling collection fee as stipulated in SCHEDULE E. If a residential or commercial occupancy requests a second roll out recycling cart the fee will be as stipulated in SCHEDULE E.
- 8. All properties regardless of their type or classification, whether developed or undeveloped will be subject to the quarterly infrastructure levy as stipulated in SCHEDULE F.

- 9. A penalty as stipulated in SCHEDULE G will be added to all utility accounts outstanding after 30 days.
- 10. If the water supply to a dwelling unit is disconnected for infringement of the provisions of this bylaw, or the Water and Sewer Services Bylaw, the same shall not be reconnected until the fee as stipulated in SCHEDULE H in by this bylaw are paid in full, along with all penalties, fees, rates, charges and arrears.
- 11. Any person desiring to purchase bulk water can do so at the water treatment plant at the fees stipulated in SCHEDULE I. Regular public works business hours are considered Monday, Tuesday, Wednesday, Thursday and Friday from 8:30 a.m. to 4:30 p.m. Noon to 1:00 p.m. is considered the lunch hour and would be considered outside of business hours.
- 12. Unpaid utility accounts for service provided to a property may be added to and form part of the taxes on the property for which the utility service was provided, in accordance with clause 369(1)(b) of *The Municipalities Act*.
- 13. Bylaw 2020-06 is hereby repealed.
- 14. The rates, charges, tolls or rents contained in this bylaw shall come into force and be effective for the billing period after the day of approval being issued by the Local Government Committee of the Saskatchewan Municipal Board or June 24, 2021, whichever is later.
