2019 Accomplishments

Outreach & Education in 2019

Diver Day Silverlaken – Partnered with volunteers and landowner to clear up water at this site in early June.

Presentations at Silver Lake Experience, August 8-11, 2019 – One on Fresh Water Needs and another on the Value of Planting with Native Plants.

Planting at Silver Lake State Park – Partnered with Wyoming County Soil & Water Conservation District, NYS Parks, local businesses and nursery specialist to complete project that started in 2017. Added an additional 275 plantings to streambed to slow flow of water and decrease sediment that ultimately flows into lake.

Water Quality Committee partners with Community Stakeholders to Plant the Third Riparian Buffer in Silver Lake Watershed

The Silver Lake Association's Water Quality Committee has partnered with landowners, government entities, and environmental experts to make inroads on projects that will stem the influx of nutrients and sediment into the lake at critical tributaries.

On October 11, over twenty volunteers and municipal workers gathered at the Silver Lake State Park to plant 225 shrubs and perennials along a tributary that flows into the lake. The site, identified by Wyoming Soil & Water as a potential problematic run-off location, was planted with native plantings suggested by a professional arborist.

It is hoped that these plantings will form a critical riparian buffer, reducing water pollution by intercepting surface runoff and filtering sediment. According to research, riparian vegetation can remove up to 90% of unused nitrogen from croplands

(https://www.nrcs.usda.gov/Internet/FSE_DOCUMENTS/nrcs144p2_043594.pdf).

In addition, riparian buffers can provide some flood protection, slow water velocities, protect against erosion, and strengthen and stabilize stream banks. An increase in native habitats is an additional bonus.

This is the third project undertaken as a result of landowners, SLA Water Quality volunteers, and Wyoming County Soil & Water joining forces to get work done to decrease the flow of sediment into the lake.

An ongoing partnership with Perry Central High School will allow for further study of this project. Working with teacher Todd Shuskey and his students, the Water Quality Committee hopes to grow our base of knowledge while at the same time encouraging further stewardship in our community for the Lake we all enjoy.

These efforts are made possible because of the support of the SLA members, Silver Lake Golf Tournament proceeds, Wyoming County Soil & Water, landowners, and numerous volunteers who allow us to partially fund these endeavors.

The Water Quality Committee continues to reach out to our elected leaders (local, state, and national) to discuss funding mechanisms for large projects, Wyoming County Soil and Water on watershed projects that stem the influx of sediment and nutrients into the Lake, and business leaders and property owners to garner their support for these

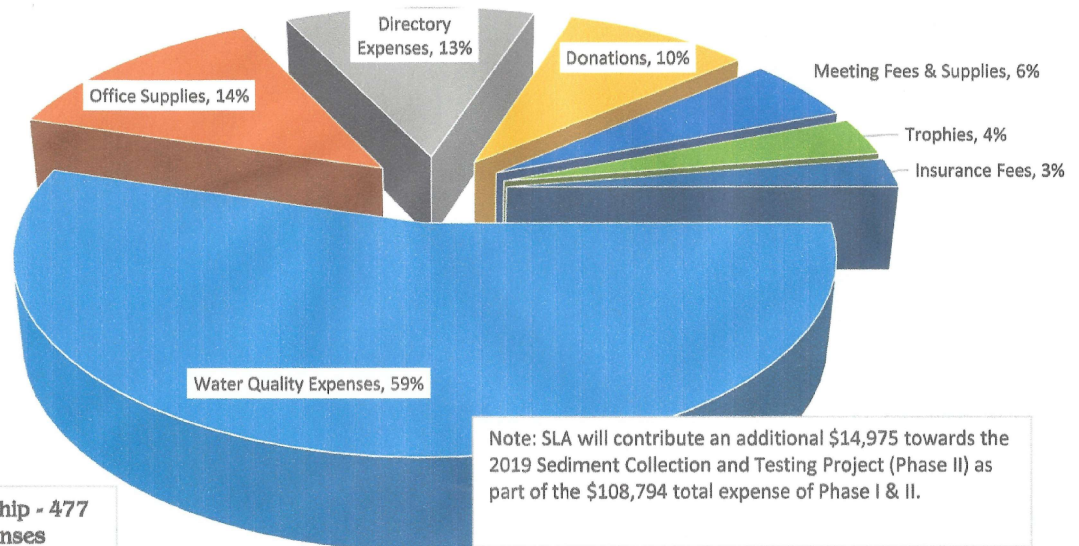

New Law for Safer Boating

On Tuesday, August 13th, Gov. Cuomo signed into law, Brianna's Law. It requires persons who operate a motorboat, regardless of their age, to have taken a boater safety course. The law is going to be phased in over a 5-year period. The information can be found on the State Parks' boating website: (parks.ny.gov/recreation/boating).

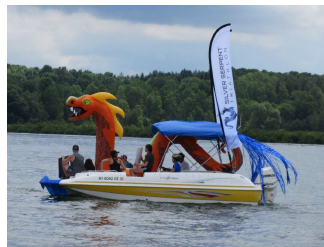
Who needs a Boating Safety Certificate?

Under a new law, known as Brianna's Law, all motor boat operators:

- Born on or after Jan. 1, 1993 will need a boating safety certificate beginning in 2020.
- Born on or after Jan. 1, 1988 will need a boating safety certificate beginning in 2022.
- Born on or after Jan. 1, 1983 will need a boating safety certificate beginning in 2023.
- Born on or after Jan. 1, 1978 will need a boating safety certificate beginning in 2024.
- All motor boat operators regardless of age will need a boating safety certificate beginning in 2025.

To obtain your safe boating certificate, you can take the safe boating course on line or attend an instructor lead course. Information is available regarding both on the State Parks boating website at: www.parks.ny.gov/recreation/boating.

Old Orchard Beach and Munger Tracts Trash Pick Up

As of the week starting November 25, 2019 Waste Management Trash pick up has changed their collection duties.

On November 25th the town of Castile met with representatives from Waste Management. Silver Lake Association leadership also attended. We were notified that the small truck used to pick up the garbage, for a few private roads in these areas, will not be available anymore. Now that the large garbage truck will be the only truck available for pick up, Waste Management can not drive their large garbage trucks down private roads. The safety concerns of the drivers and the truck getting stuck in ice and snow were the reasons this decision had to be made.

As of right now it is for the months of November through April (winter season). There will now be a drop off location for residents in 3 major areas of Old Orchard Beach North and South Tracts and Munger Tract. A notification was sent out by the Town of Castile. If you still have an issue contact your town officials.

The residents from Old Orchard Beach and Munger Tracts are to bring their trash to these corners for Monday Pick up:

1. Private Road R and East Lake Rd.
2. Lakeshore Drive and McMaster Rd.
3. Lakeshore Drive and Columbine

Letchworth Gateway Villages Year-end Update

As Letchworth Gateway Villages closes out 2019, the following are some key highlights from our work in 2019 plus a preview of what's on the horizon in 2020.

2019 Highlights

Formal Cooperative Agreement

Perhaps LGV's biggest and least publicized accomplishment from 2019 was the creation of a formal cooperative agreement between each participating municipality and community partner group. The Memorandum of Understanding (MoU) was an important first step in formalizing the collaboration beyond our initial startup phase and spelling out exactly how each partner contributes to the initiative. The agreement, which emerged from the strategic planning and community branding process undertaken in 2018, provides an adaptive framework to accommodate new communities, partners, funders and leadership as the collaboration expands and evolves.

Rural Economic Development Innovation (REDI) Initiative

In early 2019 LGV was invited by the USDA's Innovation Center to apply for a new program called REDI - the Rural Economic Development Innovation Initiative. REDI's purpose is to promote rural innovation, in particular collaborative solutions to multi-jurisdictional challenges and funding barriers. LGV submitted an application along with 38 co-applicants from five counties in the Genesee Valley and received one of the highest scoring proposals in the U.S. Through this program LGV and its network of partners (including the Silver Lake Association) have embarked on an 18-month regional planning effort to develop the Genesee Valley Region as an outdoor recreation hub.
