## INTRODUCTION

The Chapter Council Annual Report is provided on the Alpha Sigma Phi website and is due on April 15th, 2021.

For example, if you or a member of your Chapter Council attends 12 or more Chapter events per year, please check all three boxes in that section. If the minimum is not reached, please do not check any boxes in that section.
