TIME EXTENSION FOR LGRF GRANT

VILLAGE OF MELROSE

PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the <u>Village of Melrose</u> and the New Mexico Department of Transportation have entered into a joint and coordinated effort.

WHEREAS, the total cost of the project will be <u>\$360,000.00</u> to be funded in proportional share by the parties hereto as follows:

a. New Mexico Department of Transportation's share shall be 75% or \$270,000.00

and

b. The <u>Village of Melrose's</u> proportional matching share shall be 25% or <u>\$90,000.00</u>

TOTAL PROJECT COST IS <u>\$360,000.00</u>

The <u>Village of Melrose</u> shall pay all costs, which exceed the total amount of <u>\$360,000.00</u>.

Now therefore, be it resolved in official session that The <u>Village of Melrose</u> determines, resolves, and orders as follows:

That the project for this Cooperative Agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2023 and the <u>Village of Melrose</u> incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it resolved by the <u>Village of Melrose</u> to enter into Cooperative Agreement Project Number <u>L200496</u> Control Number <u>L200496</u> with the New Mexico Department of Transportation for LGRF Project for year 2021-2022 for planning, design, construction, reconstruction, pavement rehabilitation and

improvements, blading and shaping, miscellaneous, drainage improvements. The streets proposed to improve are: ABO Highway from 3rd Street to 14th Street, Higby Avenue from Brownhorn Avenue to Main Street, Higby Avenue from Main Street to 5th Street, Higby Avenue from 6th Street to 10th Street, Avenue A from Wade Street to 14th Street, 7th Street from CR11 to Highway 60/84, 7th Street from Highway 60/84 to Center Avenue, 7th Street from Center Avenue to ABO Highway, North Avenue from Brownhorn Avenue to Main Street, North Avenue from Main Street to 5th Street, North Avenue from 5th Street to 6th Street, North Avenue from 8th Street to 9th Street, Avenue B from Brownhorn Avenue to Wade Street, Avenue C from 1st Street to Main Street, Avenue C from Main Street to 7th Street, Missouri Avenue from 5th Street to 3rd Street, Missouri Avenue from 3rd Street to Brownhorn Avenue, 6th Street from Missouri Avenue to Wisconsin Avenue, 6th Street from Wisconsin Avenue to Center Avenue, 6th Street from Center Avenue to Higby Avenue, 9th Street from Highway60/84 to Center Avenue, 10th Street from Highy Avenue to Avenue A, 10th Street from Avenue A to Center Avenue, 11th Street from Avenue A to Highway60 /84, 11th Street from Avenue A to Center Avenue, 3rd Street from ABO Highway to Village Limits, Carter Street from Avenue A to End of Street, Moss Street from Avenue A to End of Street, Wade Street from Avenue A to Avenue B, Crowder Avenue from 2nd Street to 3rd Street within the control of the Village of Melrose in Melrose, Curry. New Mexico.
