The self-nomination and acceptance form shall be filed with the designated election official at the District office no later than February 24th, 2025 at 4:00 p.m., who will verify and process the form. Self-nomination forms may be obtained at the District office. An application to request permanent mail-in voter status can be obtained from the Montrose County clerk and recorder, or the office of the Secretary of State, and can be returned to the Montrose County clerk.
