Jennifer Clements made a motion seconded by Tim Blackford to approve the agenda; the motion carried.

Motion made by Vicki Riley to approve the consent agenda; Cari Cline seconded the motion, the motion carried.

Tim Blackford made a motion to table the 2022-23 breakfast and lunch prices until the July meeting. Kane Oberhauser seconded the motion; the motion carried.
