FURTHER RESOLVED that the specimen form presented shall be attested by the Secretary and filed with these Minutes.

The Secretary then presented at the meeting the proposed corporate seal. An impression of the seal appears in the margin hereof. On Motion duly made, and unanimously approved, it was

RESOLVED that the corporate seal, in the form presented and impressed hereon, is adopted as and for the seal of this corporation.

On Motion duly made, and unanimously approved, it was

RESOLVED that the Secretary is authorized and directed to obtain any books necessary and proper for the transaction of the corporations' business.

It was further moved, and adopted unanimously that

RESOLVED that the corporation's principal office in Idaho is established and maintained at 74 East Miles Avenue, Hayden, Idaho.

It was then noted that the day-to-day operation of the business demanded certain immediate decisions and acts. That often it is impossible and impractical to have meetings to discuss matters, and it was felt that a delegation of authority to the President or Treasurer to act individually was not only necessary, but imperative. After discussion, on Motion duly made, it was unanimously

FURTHER RESOLVED that the certification of the Secretary of this corporation as to the election and appointment of the President or Treasurer so authorized to sign such checks and the signature of such party shall be binding on this corporation;

these resolutions properly certified by him.	

Upon Motion duly made, and carried, it was

RESOLVED that all proceedings and acts of the incorporator of ROCKING** KNOMEOWNERS ASSOCIATION during the process of formation are accepted, ratified, and approved in all respects as the acts of the corporation.

Upon motion duly made, and carried unanimously, it was

RESOLVED that the Treasurer be and he hereby is authorized to pay all fees and expenses incident to and necessary for the organization of the Corporation.

Upon Motion duly made and carried, the following persons were selected by the Board of Directors to serve as the initial Architectural Committee to serve until the Board of Directors' annual meeting:
