## President's message for May 2023

Finally, we (except Cedar Springs) are in the midst of major curb work, which is causing headaches for those of us who have to find a place to park (not on the parking pads on Spring Forest - debris & equipment.) Milling the asphalt and paving won't start until the curb work is finished.

The circle will be closed while men are working on it. Cones will be used. Weather and supply permitting, the project should take 5-7 days for the concrete work. Once it started it might be simpler to just use 96<sup>th</sup>, rather than find out its closed and have to back up a drive to turn around.

Concrete is still on allocation for both amounts and delivery dates, which makes it extremely difficult to give us an actual schedule. Add rain to the mix and we will have to be patient.

As of April 27, here is the concrete delivery schedule: 4/27, 5/1, 5/3, 5/8, 5/12. Since you received this information the second week of May, we can see how difficult it is to promise an accurate schedule.

Once the concrete has setup enough (4-6 days) to mill and pave, the project will move fairly fast since Ace's equipment can do one side of a road at a time. We can drive on the new asphalt as soon as the roller finishes compacting the asphalt. The only completion date given me was "by July 1!"

My guess is by May 27.

Green Touch has mowed twice since we had 70 and 80 degree weather in the first part of April. I have seen Scott Brett, our COA supervisor, 3 times. It is gratifying to see a supervisor on the job, unlike last mowing season.

## **ADT Password**

It is very important that co-owners know their verbal password. ADT cannot help the caller if they cannot produce their password. If the co-owner has forgot the password, ADT will mail it to them or they can change the password.



All representatives <u>must</u> confirm your verbal password before assisting you in order to confirm your identity.

If you have forgotten your password, you can request it be mailed to you at your account address.

You may also change your password by logging onto www.MyADT.com:

- Sign into your MyADT.com account (or register if you haven't already).
- Select the Account tab.
- Select the Profile tab.
- · Click the Edit link and enter your Verbal Security Password, the press Save.

It is IMPERATIVE that all units be connected to fire and smoke alarms per our insurance. If you were not inspected by ADT in September 2022, please arrange to have that done immediately. If you are on another system, KMC must have an alarm certificate on file.

### **Recycling Electronic Products**

St. Luke's United Methodist Church recycles e-waste. They provide a permanent receptacle that you can use anytime for electronics recycling. It is located on the far north side of the church parking lot - a large tan cargo container. If it has a cord or a battery, it will likely be accepted; for example, vacuum cleaners. St. Luke's does appreciate a \$10 donation from those who use their recycling services; the donation can be left at the church office.

## Speed Limits, Stop Signs, and Walking in the Dark

Please remember to wear light clothing, clothing with reflective tape, or carry a flashlight when walking at dusk or in the dark. It is very difficult to see people wearing just dark clothing until the vehicle gets close. Hopefully it won't be "too close." Even though the walker can see the cars, the driver can't necessarily see the walker. Also, you should walk at the side of the road not in the middle and facing the traffic so you can see approaching vehicles and the driver knows you see them.

#### Mulching

It's that time of year again—mulching foundation landscaping. Over the years it has been strongly emphasized to make sure mulch is not up against the foundation bricks and lower boards. Please make sure the

mulch is graded away from the foundation. Here are a few photos of what not to do.
