- As a means to forecast roof replacement plans, Rocklane will be inspecting roofs replaced in 04, 05 and 06 to determine conditions.
- Drive seal coat quotes are in progress. Three vendors inspected the drives and auxiliary parking locations. Consensus by all three vendors is to not seal coat this year. It is suggested crack sealing be performed. In addition to sealing, vendors recommended to do no asphalt repairs at this time due to necessity and cost.
- Street repaving will begin the week of March 27. First on the list will be curb replacement, then asphalt installation.
