MOTION TO INTERVENE

Intervener, JOSEPH GILBERTI P.E., a Licensed Professional engineer in the State of Florida, pursuant to Florida Rule of Civil Procedure 1.230, and respectfully requests this Honorable Court enter an Order allowing Joseph Gilberti to intervene as witness with evidence in defense of NICHOLAS CRUZ and as grounds in support thereof states as follows:

- 1. The Defendant NICHOLAS CRUZ knew of a critical US Resource under attack at Interveners Sarasota Land from Governor Rick Scott, Marco Rubio, multiple Florida Leaders, State Attorney Pam Bondi, Broward Sheriffs office, Broward County Board of County Commissioners, Department of Education and others that is of National Importance to Healthcare and Economics to hundreds of millions of People and the State of Florida residents and was cohered to perform a Fake or partially fake shooting.
- 2. Public Defenders office knew of the US Resource and conspired with State Attorneys office to hide this US Resource with Parkland Students, Teachers, School board and Florida Leaders in an Agenda to influence election votes, create fear and steal tax base from

Schools for Florida Department of Law Enforcement.

- 3. NICHOLAS CRUZ does not have the courage or capacity to walk into a School and shoot kids just like the Officers who are afraid to help kids under lawsuits. Hence proof of Wounds, Lie detectors and more must be performed by INTERVENER due to retroactive Terrorist attacks timed with this US Resource in Courts from State and Federal all the way up to the US Supreme court now with more lawsuits by others helping coming into combine and take out the deep state of Attorneys and Department of Justice hiding this US Resource and creating potential FALSE FLAG or FAKE shootings to attack the US Constitution and tax base.

- 6. If Defendant NICHOLAS CRUZ admits in deposition to playing out an Act as Students were preparing all week for, his charges will be lowered to conspiring to steal tax base or something much less than Capital Murder.
- 7. Motion to Intervene have been filed on Civil Cases against Cruz and President Trump, Obama, Media, EPA and Lawyers ignores this hidden underground Critical in permit US Resource that brings a much HIGHER Level of Service to the Region and lowers cancer Rates, medicine sales, diseases, birth defects and deaths generated from current poor bottled Water and treated Tap water to homes, businesses and Hospitals. Its trivial that natural ready to drink out of the ground Alkaline mineral spring water is healthier than treated arsenic contaminated ground

water or polluted rivers.

- 8. NICHOLAS CRUZ has known mental issues an can be easily convinced with Police, high power politicians and Violent Video games, Movies, TV to create a potential Staged Act or even a Real Shooting in a massive Political Agenda to take guns and attack America's 2nd Amendment rights for a Agenda 21, the Midterm Elections and more. His mental capacity may be easy for him to LIE on TV if he ever even spoke or looked at the camera, which has never been seen to the Pubic thus far to our knowledge. To date nobody has seen any true gun shots, dying person live and then dead on video, or bullet wounds or real shots entering persons on video.
- 9. A ongoing staged shooting was being rehearsed all week at the Stoneman Douglas High School and NICHOLAS CRUZ was a perfect fit for a potential FALSE FLAG that could be in so much as a REAL shooting, partial shooting with actors or a total fake shooting.
- 10. Many kids want to be famous on TV and this could be a massive DRAMA ACT just like our Presidents and leaders pretending they don't know of a 300mile Antioxidant pipeline in permit from FDEP, FDOT, ACOE, EPA, FEMA, over 15 counties and 45+ Cities and presented to multiple commissioners and School Boards from Dade, Broward, Sarasota, Lee, and more. - 11. We have proof Boston Bomb was setup to raise Gilberti Bond in Tampa 12 days after Jim Murray of Amps Well Maintenance in Palm Beach performed a Down the Hole Video who has drilled Oil over ¾ of the World for decades and is a Federal known consultant who also works for Palm Beach, Broward, Collier and many other counties to maintain aquifers. He stated they were deleting emails of the screen in front of his eyes at Gilberti—Daughtrey Ranch in

Sarasota on April 3, 2013. He claimed there is no other Water Antioxidant even close on the Planet and this isolated location and resource has Endless Flow capacity and flows to keep pipes full, lower cancer, and ends Water Restrictions, Salt Water intrusion and Sea Rise concerns on Water Supply in South Florida, via Florida North South Water war per National Resource Defense council per Jeb Bush.

Victims of the Shooting, their Parents, Broward School Board and Teachers have ignored a \$17million dollar offer on March 20, 2018 by Intervener to show wounds and discuss Violent video games while Gilberti was being processed for a FAKE AR-15 emails by ex public defender on Boston Bomb game in Hillsborough, Chris Shaw, District 13 where Pam Bondi lives and worked for years, who is manipulating courts with High Power Law firms such as Morgan & Morgan, Greenberg Traurig, Foley Lardner, Icard Merrill, Henderson Franklin, Gray Robinson law, Snyder law just to name a few.
- 13. Intervener needs to depose NICHOLAS CRUZ on said issues and put him on a LIE DETECTOR to ask him if he really shot anyone, was there a rehearsal earlier in the week or if anyone convinced him to Shoot a School or fake a shooting.
- 14. Intervener needs to depose wounded Children to see if they have real wounds with forensics and determine if they knew of the offer to the School board on March 20, 2018 public record agenda.
- 15. Gov Scott, Marco Rubio, Candidates in elections, and other Leaders which many of which are attorneys and Judges manipulating State Attorneys offices, FDLE, Police Officers, Universities, School Districts, private lawyers, Hospital Foundations, Hospitals, Doctors, Cities within Broward, Dade, Palm Beach, Collier, Lee, Charlotte, Desoto, Sarasota, Hillsborough, Manatee Counties, Big Pharmacy hedge funders and Media to hide this Resource to steal Medicaid money in a massive Racketeering investigation as related to RAW Water resources for

NICHOLAS CRUZ was cohersed through Governor Rick Scott, Florida Leaders, crooked State Attorneys through various Political Agendas with US Leaders, FEMA, Gun Control Activist, Liaisons for Politicians to create a staged Shooting with FAKE Police reports regarding an AR-15 shooting where common grounds to attack Intervener Joseph Gilberti with various cases prior to, during and after with Tampa District 13 to also attack Gun control with FAKE Police Reports and Political agendas, tied to Agenda 21 with Hillsborough Misdemeanor Case 12-CM-011299A, Felony Cases 16CF010976A, 18CF004829A & 18CF005038A timed with Civil cases in Sarasota District 12, Civil Cases 2011 CA 004209 NC, 2015 CA 006544 NC and 2016 CA 000205 NC; Federal Cases with Intervener clients at the US Supreme Courts on Terrorism and this Critical Water Supply under Israel Mosaic Phosphate attack pending from US Middle District Case 9:13-bk-14831 and 11th District Court of Appeal Case 15-14544.
- 17. The Tampa District Cases involve all Attorneys who attacked the land with Deep State Cops, Judges and Lawyers who have been hiding this US Resource with FEMA, EPA, NASA and USGS agencies to keep the Level of Service Water supply very low from poor raw water resources to increase Cancer Rates, Diseases and more from bottled and Tap water to Homes of over half of Florida from Tampa to South Florida.

Tampa Misdemeanor Cases involve Greenberg Traurig who Intervener clients fired on land for Conflict of Interest as Dave Weinstein of Greenberg is Chief Council for decades for a massive Phosphate production group destroying and attacking US Aquifers in West Florida from Polk County south to Charlotte Harbor. This massive Group of Lawyers, Cops, Media and consultants with Israel Mosaic Phosphate next to our land in Sarasota-Desoto region where Gilberti ranch is located at 9438 Daughtrey Road, Sarasota Florida 34266 has manipulated Deep State Cops, Attorneys, Judges and Media in the region to attack our Family and subdue this

The Felony cases in Tampa involve Gilbert ex public defender Chris Shaw who ran off before trial in a case retroactive with the Boston Marathon explosion where Gilberti was on bond for \$500 and sent a Jog email of FDEP in a Torch Run with Herschel Vinyard and Governor Rick Scott 5hrs prior and suddenly the explosion hits, Gilberti misdemeanor bond jumps to \$300,000 and is surrounded by Secret Service, US Marshals and deep state cops. - 23. A Massive underground River showing endless Capacity of Alkaline Spring Water with Reading never seen on the planet for Health, Energy production and new medicine.
- 24. This Marjorie Stoneman Douglas Case Pollack vs Cruz Broward Case 2018-09607 has a Motion to Intervene by Joseph Gilberti pending as the Marjorie Stoneman Douglas shooting was timed exactly 17 days after a Critical World Drinking Water was submitted to FDEP State Revolving Fund on January 28th 2018 for a World Medicine changing Resource under Interveners property located at 9438 Daughtrey Road, Sarasota Florida 34266. This site is in US Supreme Courts, Sarasota to Tampa courts for years as part of the Florida North South Water Conflict; currently under Israel-Saudi Arabia Mosaic Phosphate attack working with Health Foundations, Hospitals and Big Pharmacy groups to maintain a massive racketeering operation in Lower Level of Service Water supply.

With past FDEP emails of Jog Torch run by FDLE in Leon County five hours before the Boston Bomb used to kidnap INTERVENOR with Tampa Dist 13 and Governor Rick Scott, Marco Rubio, Obama, Bill Nelson and more, just to name a few, this case is also part of other cases in the State and Federal system.
 - 27. Sarasota Cases 2015 CA 006544 NC and 2016 CA 000205 NC has the Marjorie

Stoneman Douglas shooting involved. US Federal Cases involving the land next door also include multiple terrorism acts and this shooting which is being reviewed by FBI and US Supreme Court under Daughtrey vs Rivera Trustee. Also Tampa Cases under Joseph Gilberti Jr. show additional information where Pam Bondi and Tampa District 13 Judges filed fake AR-15 emails the week of the Pulse Bar shooting on INTERVENER to time the kidnapping two weeks after the Marjorie Stoneman Douglas offer in 2018 with bond games and hikes.

- 35. Intervener, JOSEPH GILBERT, P.E., have the requisite interest in this case to permit their intervention because the issues they seek to raise are encompassed by the present controversy between the parties to this case. See <u>Union Cent. Life Ins. Co. v. Carlisle</u>, 593 So.2d 505, 507 (Fla. 1992) (Intervention should be permitted where the parties' interests are "of such a direct and immediate character that the intervener will either gain or lose by the direct legal operation and effect of the judgment.") Consequently, intervener JOSEPH GILBERTI P.E., is appropriate party to this case.
- 36. Leave to intervene shall be given freely when justice so requires and is greatly favored in Florida. See Florida Rules of Civil Procedure 1.230; National Wildlife Fed'n Inc. v. J.T. Glisson, 531 So.2d 996, 997 (Fla. 1st DCA 1988) ("Intervention should be liberally allowed."); see also Miracle House Corp. v. Haige, 96 So.2d 417, 418 (Fla. 1957).
- 37. The granting of this Motion to Intervene will not unduly delay this action or prejudice any of the parties because the action of the intervener's doesn't damage NICHOLAS CRUZ but shows the Court potential corrupt coordination between State Attorneys office in Broward, Sarasota, Lee, Hillsborough and US Middle District without due process has already inextricably linked the interveners to this action.

WHEREFORE, Intervener JOSEPH GILBERTI, P.E. this Court: respectfully requests (a) grant this motion to intervene as witness for the defendant and to obtain all files to coordinate a upcoming Racketeering and Class Action lawsuit; (b) direct the Clerk to amend the style in this case to reflect the interventions; and (c) for such other and further relief as the Court deems just and proper.

Section 701-706) against the U.S. Environmental Protection Agency (EPA), Acting Administrator Andrew Wheeler in his official capacity as EPA Administrator, and against Mary

- S. Walker in her official capacity as EPA Regional Administrator for Region IV, for their failure to perform EPA's following non-discretionary duty under Section 303(d) of the CWA and 40 C.F.R. §130.7 and Failure to utilize an available Underground hidden Alkaline Spring Water River known for 40yrs by Southwest Florida Water Management District, EPA officials and staff, Department of Interior, Manatee, Hillsborough, Desoto, Charlotte, Lee, Collier and Sarasota counties for HIGHER LEVEL OF SERVICE Raw Drinking Water Resources to millions of Florida citizens to Lower Cancer Rates in the Region at the Tap. Current FDEP Regulations 62-555 (310) as written pursuant to the EPA Clean Water Act of 1974 and its revisions and additions thereto.
- 1. Peace River Manasota, Sarasota, Charlotte, Manatee Counties, City of North Port, City of Punta Gorda have hidden this US Resource to fill cancer centers with Medicaid Fraud Gov Scott and a massive Racketeering Act to sell medicine and fill Cancer Centers. Current City of Punta Gorda utilities is expanding a Shell Creek Treatment facility and purposely ignored a Sarasota 2014 transmission permit application submitted by LandTech to connect to the Peace River Manasota Water Supply board owned by Sarasota, Desoto, Charlotte and Manatee county. These counties are stealing medicaid money by pumping a known Arsenic River to millions of Homes and ignoring this Spring Water unique Natural Resource that is not a spring but a massive underground River with Alkaline readings from a Titled platform from the K-T Event. 





<u>Title XXIX</u> PUBLIC HEALTH Chapter 403 ENVIRONMENTAL CONTROL

SECTION 851

Declaration of policy intent.

403.851 Declaration of policy; intent.—It is the policy of the state that the citizens of Florida shall be assured of the availability of safe drinking water. Recognizing that this policy encompasses both environmental and public health aspects, it is the intent of the Legislature to provide a water supply program operated jointly by the department, in a lead-agency role of primary responsibility for the program, and by the Department of Health and its units, including county health departments, in a supportive role with specific duties and responsibilities of its own. Without any relinquishment of Florida's sovereign powers and responsibilities to provide for the public health, public safety, and public welfare of the people of Florida, the Legislature intends:

- (1) To give effect to Pub. L. No. 93-523 promulgated under the commerce clause of the United States Constitution, to the extent that interstate commerce is directly affected.
- (2) To encourage cooperation between federal, state, and local agencies, not only in their enforcement role, but also in their service and assistance roles to city and county elected bodies.
- (3) To provide for safe drinking water at all times throughout the state, with due regard for economic factors and efficiency in government.

18. Background on Natural Alkaline spring water to the Region and cancer rates shown by Nobel Peace prize winner Dr. Otto Warburg in 1931. The Warburg hypothesis (/ˈvɑːrbʊərg/), sometimes known as the Warburg theory of cancer, postulates that the driver of tumorigenesis is an insufficient cellular respiration caused by insult to mitochondria. The term Warburg effect in oncology describes the observation that cancer cells, and many cells grown in vitro, exhibit glucose fermentation even when enough oxygen is present to properly respire. In other words, instead of fully respiring in the presence of adequate oxygen, cancer cells ferment. The

Warburg hypothesis was that the Warburg effect was the <u>root cause</u> of cancer. The current popular opinion is that cancer cells ferment glucose while keeping up the same level of respiration that was present before the process of <u>carcinogenesis</u>, and thus the Warburg effect would be defined as the observation that cancer cells exhibit glycolysis with lactate production and mitochondrial respiration even in the presence of oxygen.^[2]

Hypothesis/edit/

Warburg's hypothesis was postulated by the Nobel laureate Otto Heinrich Warburg in 1924.^[3] He hypothesized that cancer, malignant growth, and tumor growth are caused by the fact that tumor cells mainly generate energy (as e.g., adenosine triphosphate / ATP) by non-oxidative breakdown of glucose (a process called glycolysis). This is in contrast to healthy cells which mainly generate energy from oxidative breakdown of pyruvate. Pyruvate is an end-product of glycolysis, and is oxidized within the mitochondria. Hence, according to Warburg, carcinogenesisstems from the lowering of mitochondrial respiration. Warburg regarded the fundamental difference between normal and cancerous cells to be the ratio of glycolysis to respiration; this observation is also known as the Warburg effect.

Cancer is caused by <u>mutations</u> and altered gene expression, in a process called <u>malignant transformation</u>, resulting in an uncontrolled growth of cells. ^{[4][5]} The metabolic difference observed by Warburg adapts cancer cells to the <u>hypoxic</u> (oxygen-deficient) conditions inside solid tumors, and results largely from the same mutations in oncogenes and tumor suppressor genes that cause the other abnormal characteristics of cancer cells. ^[6] Therefore, the metabolic change observed by Warburg is not so much the cause of cancer, as he claimed, but rather, it is one of the characteristic effects of cancer-causing mutations.

Warburg articulated his hypothesis in a paper entitled The Prime Cause and Prevention of Cancer which he presented in lecture at the meeting of the Nobel-Laureates on June 30, 1966 at <u>Lindau</u>, <u>Lake Constance</u>, Germany. In this speech, Warburg presented additional evidence supporting his theory that the elevated <u>anaerobiosis</u> seen in cancer cells was a consequence of damaged or insufficient respiration. Put in his own words, "the prime cause of cancer is the replacement of the respiration of oxygen in normal body cells by a fermentation of sugar." [2]

The body often kills damaged cells by <u>apoptosis</u>, a mechanism of self-destruction that involves mitochondria, but this mechanism fails in cancer cells where the mitochondria are shut down. The reactivation of mitochondria in cancer cells restarts their apoptosis program.^[8]
