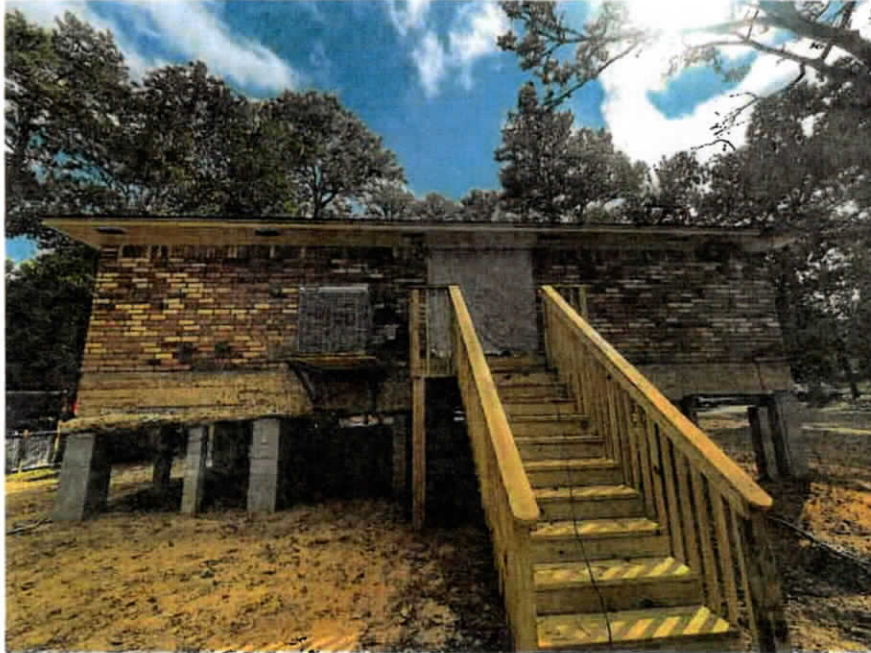


Photo Three Caption **Side of Home 10-14-2022**
