The attached Ordinance, now designated as Ordinance No. 2019-1090, was introduced by Council Member Reed: An Ordinance Of The City Of Tecumseh, Nebraska Amending Sections 2.02.371, 5.05.04.07, 5.06.05.01, 5.07.05.1; Adding Sections 4.12.06.05, 4.12.06.06. 5.05.02.12, 5.05.03.15, 5.12.02.12, 5.12.03.14; Deleting Sections 5.05.04.08 And 5.13 Of The Tecumseh Zoning Ordinance: To Add A Definition Of Storage Container; To Provide That Travel Trailers, Mobile Homes, RV's, 5th Wheel Trailers And Campers Cannot Be Used For Animal Shelters; To Provide Storage Containers Cannot Be Located In Residential Areas, Except For Limited Circumstances; To Allow Mobile Home Courts And RV Parks In Light Industrial Districts And Ag Districts; To Change The Section Number For Solar Provisions; Deleting Section Due Renumbering Of Solar Provisions Sections; To Provide For Outdoor Storage Areas; To Add That Side Walls Of Accessory Buildings May Exceed 10 Feet With A Conditional Use Permit In Low Density And Medium Density Residential Districts; And To Delete Mobile Home Provisions In Zoning Ordinance Since Now Defined In City Code and moved that the statutory
