Utility Dept. Report- provided by Doug Goracke, Replaced three poles. Three after hours service calls. Keith at Sargent called to inquire about having a spare actuator for the 12th and Webster Valve (10 week lead time to get is the reason). NDOT doing Hwy 50 project in the Spring/Summer, we will need to lower the 4" water main at Clay Street. (Agenda Item). We will also look to fix past problem at 11th and Clay, and 9th and Clay at same time. Replaced 12 diffusers at the Aeration Cell at the WWTP. Repaired water main...2nd and Lincoln-north.
