TREASURER'S REPORT: Beckman presented the 12/31/2023 Treasurer's Report and 12/31/2023 budget update showing a checking account balance of \$231,834.68 and a total fund balance of \$1,216,407.03 which is a difference of \$161,404.61 more than last year at this time. Motion by Newman/George to approve the Treasurer's Report as presented. Motion Carried.

Members reviewed the proposed 2024 Budget. Motion by Hitt/George to approve the budget as presented. Motion Carried.

POLICY UPDATES: Members reviewed a recommended update to the Expense Reimbursement Policy allowing for \$100 stipend to attend in-person meetings and a \$50 stipend to attend virtual meetings. The current \$50/\$25 has been the policy for more than 20 years. Motion by Scanlan/Tallier to approve the policy as presented. Motion Carried.

LSR PRESENTATION: The LSR Presentation was tabled until the April meeting.

PROJECT RANKING AND 2024 PROJECT AWARDS Council members in attendance and eligible to vote, received a project ranking sheet. Heimerman asked that members be allowed to vote to decline a project outright prior to completing the ranking sheet. Members received instructions to complete the sheet by ranking projects from 1 to 10 based on how they align with the Lumberjack mission, one being it doesn't align at all and 10 being that it aligns fully and to leave it blank or put in zero if they feel the project should not be funded. With 14 members in attendance and eligible to vote, there was a total of 420 possible points. Members completed their sheets and turned them in to VP Sommer.
