- 2. That in the aggregate the number of valid signers of the petition/s equal or exceed the number required by law. Contact municipal clerk or county clerk for signatures required.
- 3. That one or more of the signers of each petition verify the petition on his or her oath of affirmation. 19:23-11.
- 4. That the signers are qualified voters and reside in the political subdivision for which the candidate stands for office.
- 5. That the candidate/s endorsed in the petition fully complete and execute one or more petitions with respect to qualifications, consent and acceptance (R.S. 10:23-7)
