Instructions

2. Petitioners must sign in their own handwriting in the presence of the person who will sign as the circulator of the petition, giving their residence address. Petitioners must also print their name in the space provided.
3. The person in whose presence the petition was signed must sign the petition and make the affidavit before some officer authorized to take affidavit.
4. The candidate must sign the certificate of acceptance, stating that he is qualified for the office and a member of the political party mentioned in the petition.

Information on circulating and filing petitions (R.S. 19:23-10)

One or more petitions may be circulated and one or more petitions filed on behalf of candidate/s providing:

1. That all petitions are filed on or before 4 p.m. on the **29th** day preceding the day of the primary election.
2. That in the aggregate the number of valid signers of the petition/s equal or exceed the number required by law. **Contact municipal clerk or county clerk for signatures required.**
3. That one or more of the signers of each petition verify the petition on his or her oath of affirmation.

4. That the signers are qualified voters and reside in the political subdivision for which the candidate stands for office.
5. That the candidate/s endorsed in the petition fully complete and execute one or more petitions with respect to qualifications, consent and acceptance (R.S. 10:23-7)
