Client agrees to pay all amounts due under this Agreement. If the Client cancels the contract date or contract period for any reason, a minimum of 4 weeks notice will be required for a full refund. However, in the event of a postponement by the Client, the Artist will work with you to arrange an alternative date based on the Artist's previous commitments.

### Overtime:

Unexpected overtime on the day of the event will be charged per half hour at £50 per hour or £25 per half hour per Artist, however only time booked in advance is guaranteed. Any unexpected additional time may not be available on the day of the event, but the Artist will try to accommodate requests for additional paid time if needed.



### **Booking Date:**

A date is reserved for the Client only after the deposit has been paid and the contract has been concluded. The signed contract will be emailed to the Artist by the Client and the 25% deposit will be paid. If the deposit is not received within 3 days after receipt of the signed contract, the Contractual agreement is void.

If the Artist is unable to perform the service after the contact has been signed and returned, the deposit paid will be refunded to the Client.

### **Parking:**

The Artist will require parking near where the service takes place to unload/load equipment.

### **Limitations:**

Artists do not paint on parts of the body that are forbidden to be exposed or where they feel uncomfortable painting. Artist do not draw any designs or words that are obscene, offensive, or contrary to common sense. Artists may refuse to paint symbols or other illustrations that may offend. Artist does not depict copyrighted characters or designs.

### **Working Conditions:**

Artists have the right to stop painting and leave without refunding if there is a problem with working conditions and the situation could not be remedied by the Client after informing them.

Adverse conditions include:

Destructive, violent, offensive, or extreme inappropriate behaviour by children or adults. Illegal activity. Hazardous weather, poor working environment conditions or dangerous general conditions.

### **Artist's Responsibilities:**

- a. The Artist will arrive at the event location on time and ready to provide services as agreed upon.
- b. The Artist will use professional-grade, hypoallergenic products and adhere to proper hygiene practices.
- c. The Artist will provide a variety of designs for the Client and guests to choose from.
- d. The Artist will work diligently to ensure that all willing guests are accommodated during the event.

### **Client's Responsibilities:**

- a. The Client will provide a designated area at the event venue for the Artist to set up and conduct face painting.
- b. The Client will ensure that the Artist has access to a water source and adequate lighting for working.
- c. The Client will inform the Artist of any guests with known illnesses, allergies or skin sensitivities to face paint/glitter.



## **Cancellation and Refund Policy:**

- a. In the event of cancellation by the Client less than 4 weeks before the date booked, the deposit paid will not be refunded.
- b. In the event of cancellation by the Artist due to unforeseen circumstances, the Artist will refund the full deposit to the Client.

## **Liability:**

The Artist is not insured to paint children under the age of 3. For hygienic reasons, the Artist does not paint people who have or appear to be ill or has wounds, conjunctivitis or any infectious skin disease. The artist will take reasonable care but is not responsible for any damage to clothing or clothing property.

## **Intellectual Property:**

- a. The Artist retains all intellectual property rights to the face painting designs created during the event.
- b. The Client agrees not to reproduce or use the face painting designs for commercial purposes without the explicit written consent of the Artist.

## **Agreement Modifications:**

Any modifications or amendments to this Contract must be made in writing and signed by both parties.
