HIEF'S CORNER Leo Chaloux It is that time of the year again when I have to start dealing more with money and accounting procedures. Every year at this time I have to prepare a budget to be submitted to the Mosquito Fire Protection District Board of Directors. The budgetary process, because it deals with tax payer dollars is a very specific one outlined by state law and county auditing procedures.

I have to have a preliminary budget in front of the Board of Directors by the board meeting date in May. They in turn review the budget and must have it adopted by the June meeting date. In July we start receiving preliminary information on the financial status of the District from the County Auditor's office. In October we receive accurate closing information on the previous fiscal year from the County and adopt the preliminary budget with the necessary adjustments as the final budget. The final budget is submitted to the County Auditors office for their review.

This process is a strange and difficult one as a budget should be as accurate a guideline for financial accountability as possible. Some of the problems that Board members and I have in preparing this budget is that we do not know how much revenue has been collected by the County Assessor's office until around the end of September and on some occasions it has been in October. Yet we are supposed to have a final budget in place by October. We do not always have up to date information from the County Auditor,s office in relation to money expended or money carried over from the previous fiscal year. It seems that everything coming from the County is at least two months behind time. Thank God, I have Lois Pearson, the District Secretary, maintaining the books. Her information is always timely and extremely accurate.

Often people do not know how fire departments are financially run. The laws are very specific as to how money is to be collected, allocated, expended, controlled, and audited. Every tax dollar collected in the district is done so by the County Assessors office. The percentage of Ad Valorem the District is entitled to, the entitlement is established by the County Board of Supervisors, is then placed in the County Auditor's office for their control. We never see money here. I can only purchase something that has either been budgeted or falls within a budgeted category approved by the Board of Directors. When an item is purchased it is only done so by a Purchase Order, FAX order or phone order with my approval. Once the item and bill are received I present the bill to Lois who in turn checks to make sure the bill and item are proper and fall within the budgeted category. Lois prepares a voucher for the billed item and the bill along with the voucher is then presented to the Board Members at each monthly board meeting. All five Board Members then review the bill, the voucher, and the fact that the item purchased was necessary and meets the criteria of being a budgeted item. Once the approval of all this is given by the Board Members everything is presented to the County Auditors office where all is reviewed by a auditor for

approval and than a check for the vender is cut by the County.

By state law the District must have its entire financial status reviewed by an independent auditor. We could use the County to perform the audit but they take too long and charge too much so we utilize the services of an independent Certified Accountant. Every November he goes through the District's entire financial records and accounts. He presents his findings to the Board of Directors for their review. By law, any deficiencies or inadequacies that are discovered have to be responded to by the Board of Directors in writing.

The ultimate auditor is the tax payer. The District's budget is available to the public for review. Any questions, concerns or comments can be brought to any Board meeting as they are all open to the public. In fact we would enjoy some public participation.

I was once told that I should be able to run the entire Fire District on \$5,000 a year. I laugh over that every time I think of it as the above auditing process alone costs the District almost \$5,000 every year. Nothing is free to the Fire District, everything we do has a cost, in fact we even pay state sales tax on all items purchased. People are often surprised when they discover that we have to buy our own fuel and pay for workers compensation insurance for the volunteer fire fighters. In reality the Fire District is a business that has a revenue source and offers a service in return. That service is to provide fire protection and medical assistance at the lowest possible cost. The amount of service provided is in direct relationship to the amount of revenue (tax dollars) collected. As with all things in life; anything is possible for it is simply a function of money.

The above process pertains to the

Mosquito Fire Protection District. The Protection District was established by state law and is classified and governed as a Special District. A second organization, the Mosquito Volunteer Fire Department, is independent and separate from the District. It is classified as a 501 (c) 3 non profit organization and cannot generate income for profit. The Volunteer Fire Department works entirely on donations. It does not collect a single tax dollar or is it given any. It has a separate Board of Directors whose members are elected by the public at a regular meeting held every November. I am the paid Chief of the Mosquito Fire Protection District and the Volunteer Chief for the Mosquito Volunteer Fire Department. Those are two of the many helmets that I put on depending on what needs to be done.

It is the Volunteer Fire Department that has raised money through donations and fund raisers that has purchased many items that have been in turn donated to the Fire District. Just recently the Volunteer Board helped purchase, with a \$2,500 donation, a new Lif Pak 500 Defibrillator. Without the Volunteer Fire Department this item could not have been purchased. Anyone having a heart attack due to ventricular fibrillation will greatly appreciate the fund raising efforts of the Volunteer Department as this machine can save their life. There have been many occasions when the District did not have the funds to purchase a needed item and I have gone to the Volunteer Fire Department asking them for money and it has been given. The Volunteer Board also has established accounts that are set aside to help people within our community that need help. Difficult situations and bad things sometimes happen and the Volunteer Board has used donated money to help many people get through it. The tables and chairs that are available to community members for their use are owned by the Volunteer Department. The Volunteer Fire Department belongs to the entire community and is supported by the many fine people that work hard to acquire these donations where as the Mosquito Fire Protection District belongs to the tax payers.

The Mosquito Volunteer Fire Department also has public monthly Board Meetings and again everyone is encouraged, and is in fact needed, to attend.

The Mosquito Volunteer Fire Department meets on the first Thursday of each month at 7:00 in the evening. The Mosquito Fire Protection District meets on the second Thursday of each month at 7:30 in the evening. Hope to see you at both of these meetings which are held at the Fire Station.

FINNON LAKE UPDATE Leslie Keene

We've had a slight change in what we've reported to you before as to what our plans for the Finnon Lake Resort are. We had originally thought to include a small store to sell camping supplies as part of the restaurant, but the Wildlife Conservation Board (part of the Department of Fish and Game), from whom we acquired the property, has ruled that "a grocery store would exceed the 'public recreational/open space' limitation on use of the property." However, we can and will continue to provide a small amount of camping and fishing supplies, including bait, just as we do now.

We continue to be hampered by the weather in accomplishing getting water to the resort. The water meter is installed, the necessary pipe has been acquired, and as soon as the weather allows, this will be a priority.

The dam is also a priority and, again, we have been slowed down by the weather. As mentioned before, we need to burn off the brush and berries on the dam before the necessary surveying can occur. Once we have drier weather, CDF will be here to help us.

At our public information meeting on June 4th, we will explore each of these tasks in as much detail as you like. Basically, we are concentrating our efforts on:

- 1.Dam Restoration
- 2.Water to the Resort
- 3. Restaurant Renovation

4. Existing Campground Renovation

CLEARING RECORD ON MOSQUITO FIRE DEPARTMENT

False and wild statements are being circulated by people ignorant of the facts that the Mosquito Volunteer Fire Department, and the Mosquito Fire Protection District, are two separate entities..

When the developer came to Mosquito, he was supposed to furnish a fire department and equipment. His ideas was to join up with Garden Valley Fire Department, which was too far away for the response we needed. So, in 1972, four people, myself included, by a lot of hard work, began organizing the Mosquito Volunteer Fire Department, getting our Charter in 1973. Through fund-raisers and donations, we acquired some equipment, which along with Orval Beckett's bulldozer and water truck furnished fire protection. The developer and his backer donated land and material.

With volunteer labor and more donations we were able to build a fire station. We were able to gradually add to our equipment. Our volunteer firemen needed proper gear and insurance coverage, which were far too expensive for all the hard labor, etc., that the Volunteer Fire Department could scrape together.

So, in the November 1977 election,

which we had worked to accomplish, we were lucky enough to become a fire district. We went into business as a fire protection district as of Jan. 1, 1978 a tax supported entity with our own elected board of directors. Our tax money goes into the El Dorado County Treasury, from which it is administered through the El Dorado County Auditor's office. We receive a certain amount of tax money along with our Special Assessment fee, which was also voted in by the people. ŕ

It is all held in the El Dorado County Treasury. We formulate and adopt a budget every year, based upon the amount of tax money we are allowed. We have to live within that budget. The volunteer department can give money to the district, which they often do, by buying equipment the district cannot afford. In turn, the district cannot give any money to the volunteer department.

When the district was formed, the volunteer department turned over all of their assets to the protection district.

Through their charter, the Mosquito Volunteer Fire Department, which was organized and operated exclusively for charitable and educational purposes, has a tax exempt status under Section 501(c) of the Internal Revenue Code and Section 23791 d. of the Revenue and Taxation Code.

In August 1997 it acquired Finnon Lake, which includes 120 acres. It was all done fair and square, with no help from the fire protection district. Records can be verified with the California Department of Fish and Wildlife, or Fish and Game, and any other bureaus involved. The volunteer department has a clear deed to the property.

The volunteer department was advised to remove the dead "beetle" trees from the Finnon property. The proceeds are being put back into the property by installing a potable water supply, and maintaining the property in general. they have many offers of help and many donations.

We want it to be known, by those who don't know any better, that the Mosquito Fire Protection District has not, cannot, and will not put any money into the "Finnon Lake Project." Their budget alone does not allow it, as their money is too controlled by law. Hopefully this will clear up all the false, wild statements being spread around.

The fire protection district's records are kept at the El Dorado County Auditor's office for anyone to verify. There is nothing to hide, and the district's records are audited yearly by an outside auditor.

People should go the board of directors' meetings monthly and see how the "other half lives."

Another good recipe from our Marshal Hospital cook book. Very good - can be made in 3 flat throw away pans to be given as gifts. Great in the summertime. Light and refreshing.

LEMON JELLO CAKE

½ c. oil

³/₄ c. water

4 eggs

l regular size pkg. lemon jello

1 pkg. yellow cake mix

Mix first four ingredients. Add cake mix. Bake 45 minutes at 350° in prepared 9 x 13-inch pan. While cake is still hot, with a large fork punch top of cake many times. Pour the topping mixture over the cake, filling the holes. **TOPPING**:

 $\frac{1}{2}$ c. lemon juice

1 1/2 c. powdered sugar

Mix together.

Orange, lime or pineapple may be used instead of lemon. A matter of taste.

EATHER CORNER Jim Hinds ATMOSPHERIC

This is the second attempt to get this report to the Editors of the *Byte*. The first edition was swallowed into the innards of this wonderful machine that we have been told we cannot live without and that it will make our lives fuller and more complete. At any rate the article is either on its way or has arrived in Cyber Heaven. May it rest in peace.

May is not noted for its abundance of rainfall. The 125 plus year average is less than $1\frac{1}{2}$ inches. We have been subjected to a little less than $5\frac{1}{4}$ inches this year, which is well above average for May. We have accumulated $63\frac{3}{4}$ inches of rain this year to date May 22. We have 39 day to go in this weather year, let's hope it levels out just a bit and gives us some nice spring weather for a change. These cold and clammy nights are getting a little monotonous and my wood supply is dwindling rapidly.

Last month I mentioned that some years we had less than 20 inches rain for a year. Going back through my records I found two years that fit this description:

1975-76 18.94 inches of rain 1976-77 17.36 " " "

A few of us, and we were fewer back then, were concerned we would dry up and blow away. We managed to water newly planted fruit and nut trees with the aid of buckets from one water spigot and little ditches from tree to tree. The ground was so dry it looked like a dried up lake bed with cracks all over the place even in the place where the lawn had been. We did end up the 5 year average with a respectable 35.96 inches. Our yearly average seems to be around the 40 inch rainfall mark. Be grateful for abundance received. This year is already considerably above average.

ASTRONOMIC

Let's start with the Sun this time. It has been hidden by clouds for so long it is a real pleasure to see it again and over a week too. As you know our Sun appears to travel North for Summer and South for Winter in this Hemisphere. During this month it will arrive at its most northern position which is an imaginary line drawn on World maps and Globes. This line is called the Tropic of Cancer and it located $23\frac{1}{2}$ degrees north of the Equator. When it arrives at 7:03 a.m. June 21, Summer will begin and the apparent movement of the Sun will be southward.

There is another line on world maps and globes, $23\frac{1}{2}$ degrees south of the Equator known as the Tropic of Capricorn. The Sun will be directly over it on December 21. This will be the beginning of our Winter. Why $23\frac{1}{2}$ degrees, you ask? Because our Earth is not spinning on its axis in a vertical position but its north axis points more or less to the North Pole by the same $23\frac{1}{2}$ degrees. Otherwise the seasons would always be the same. No Summer, no Fall, no Winter and no Spring. That would be very boring. June 21 has a name and it is called the Summer Solstice and it is the longest day of the year. At 40 degrees north latitude the day is 15 hours long and of course the night will be only 9 hours long. If the Earth were not "tipped" the day and night would always be the same length.

The Moon is next in line. It will be at first quarter on June 1, full June 9 and a tiny sliver on June 25. Only Jupiter and Saturn will be telescopic quality during June with Saturn's rings tilted 15 or 16 degrees making a very nice appearance by mid-month. The other planets are not viewable during most of the month of June.

If you are planning to see the movie Deep Impact, please bear in mind it is only a movie. Of course anything is possible. There are several scars visible on our Earth where some object may have collided with us. Meteor Crater in Northern Arizona being one of them.
