PLAYER COMMITMENT: I understand that I want to have fun, learn a lot about baseball, and be a good teammate so I commit that I will:

- be a good sport (I will not take myself or this event too seriously);

- respect the feelings and property of others;
- immediately let a Staff Member know if I am injured, ill, or incapable of playing; and
- always hustle, do my best, and have a blast.

PARENT COMMITMENT: As a legal guardian of the player listed below, I/we understand and agree that:

RELEASE OF LIABILITY:

- we release RGSW, the host of Runner Gunner Slugger Worldwide events (Camps, Leagues, Derbys, and others), from all claims, demands, actions, and causes of action of every kind or nature resulting from our player's participation.
- we will not hold RGSW, its Board of Directors, officers, coaches, instructors, facilities, staff, agents, attorneys, or volunteers liable for any injury or illness or malady to our player which may occur by participating in any RGSW-related activities.
- the possibility of injury and/or illness and/or malady exists as a result of participation in the activities coordinated by RGSW and that RGSW assumes no responsibility for any such injury or illness or malady.
- we will be solely responsible and liable for the administration of any medication or treatment required by our player, if, in the judgement of RGSW, should need immediate care and/or treatment as a result of any injury or sickness.
- we do hereby request, authorize, and consent to such medication and/or treatment, as may be given our player by any licensed medical or dental professional, trainer, nurse, or RGSW representative simultaneously hereby agreeing to indemnify and save harmless RGSW and any health care provider from any claim by any person whomsoever on account of such care and treatment of our player.
- we agree to indemnify, defend, and hold RGSW harmless from any and all liabilities and claims, costs, and expenses, including those arising from, or caused by, any negligent acts or omission by RGSW.
