Old Business

November's SWR Educational Seminar Overview:

Denise will submit the invoice from the Carson Field from David Mott's and/or Steve Garvin, Nelli Racsko will submit one for the Tracking Fundamentals Seminar and Oscar Mora for the Obedience and Protection Seminar. Bob will submit all documentation to USCA for the region to get a refund. Total of invoices is \$1,500.00.

Total amount collected from the two day seminar is \$2,114.00.

The Board was happy to discuss that by opening the seminar to non USCA members as spectators there was a significant increase overall in interest and revenue. Nelli reported knowledge of seminar attendees signing up for new usca membership after the weekend. It was also discussed that "working spots" at these annual educational seminars (if offered) need to remain being only available to current USCA members. The Board also discussed that the SW Region should make these educational events more inclusive in the future by allowing non-members to attend as spectators, possibly for a slightly higher cover charge (\$5.00-10.00 extra?). New Business

SCSC waiver for 2023

SCSC's December Trial had to be cancelled due to lack of entries. However, the club did put on an educational seminar earlier in the year but did not fill out an EAF. Waiver was granted by Nelli with the board in agreement.

Regional Breed Show

December 2, 2023 hosted by Sandstorm Schutzhund Club.

Little information was given to the Board regarding the event. Steve will attend event and shadow the judge and the ring steward. Up to \$1000.00 will be reimbursed to Sandstorm Schutzhund Club when the Board receives an invoice from the club after the event.

Preliminary agenda for this meeting is:
