Supervisors, Richard and Jeff Stabnow discussed the tarring project that was completed on Hidden Valley LN. There are issues with the driveway or approaches onto some of the driveways. Jeff Stabnow will check with Mark Lee regarding these issues because when the project was completed in the late fall the weather conditions changed dramatically within few days so these driveways that need some work may need to wait till spring of 2019. All agreed that in future when other roads are resurfaced there needs to be discussion about putting at all driveways regulated swing-away mail boxes. Jeff Stabnow and Board agreed to continue to look into the parking situation at the access on west side of Lake Miltona so hopefully before spring there will be a solution to this problem. Mowing of the ditches is being worked on and if weather cooperates it will be completed soon.

Clerk will mail 2019 fire protection agreements to Ida and Effington Townships, there were no changes for the 2019 year.
