Fire Chief discussed with Board the fire department would like to have a \$10,000.00 voluntary contribution made to PERA from the Fire Fund. Motion was made and second with Dale Diedrich, Brent Ost and Keith Schultz voting aye to make this contribution no other discussion needed motion carried.

Board and Road Maintenance Engineer discussed work completed on Ruckheim Rd., Effington Township will be sent invoice for share of cost project. All roads are in good condition for winter weather conditions.

Clerk informed Board filing dates for 2022 elections.

At this time the Supervisors opened letters clerk received back from residents on Hidden Valley regarding improvements of that road. There were 17 returned notices, 28 signatures were in favor of work being completed and 2 against. It will be discussed at January meeting Board agreed that there is a lot of miscommunication regarding this project this will give residents opportunity to hear and hopefully understand and return notices.
