

# someone to know Jill Surace

## This month, get acquainted with one member's revolutionary spirit!

**She's in the spotlight** at every PVPRWF luncheon and board meeting, analyzing and projecting the important details of our association's income and expenditures while referencing the detailed spreadsheets she prepared for our edification.

Jill Surace, however, is far more than a numbers nerd. She's a revolutionary! In her various community leadership roles, she is well-known as a contributor to an organization's goals and is respected for reforming and improving its operations when appropriate.

For instance, since becoming a PVPRWF member in 2018, Jill has revolutionized ★ our member-application process, setting up an online system as membership chair in 2021–2022:

- ★ our accounting system as treasurer since 2023;
- ★ our website, managing a complete overhaul last year; and
- ★ our new email system, also implemented last year.

And since 2020, she's solicited and reviewed entries and awarded monetary prizes as chair or co-chair of our annual high school scholarship essay contest. Jill says, "Staying active with this project is a perfect way for me to maintain a hands-on interest in young people."

Jill's interest in and involvement with both finances and students is significant and includes a stint as president of the Peninsula High School PTA. During her two-year term, she revolutionized the organization's accounting system, bringing it up to date with improved analytical and reporting software in addition to implementing its online membership system. Currently, she's a member of the PVPUSD Parcel Tax Citizens' Oversight Committee, created as a result of the passage in 2011 of Measure M. She explains that, "We oversee the allocation of approximately \$10 million annually to schools, paid through the property taxes of the Peninsula's citizens."

A Massachusetts native, Jill earned a bachelor's degree in political science from Bates College in Lewiston, Maine, and an M.B.A. from Suffolk University in Boston. However, with her first postgraduate jobs in accounting and finance in the mid-1980s, her talents in these fields were discovered and developed just as the 401k and computer revolutions took off. To expand and solidify these talents, she moved to California in 1990, where she worked for an international human resource consulting firm and was involved in the many details of

myriad benefit plans of Fortune 500 companies, eventually becoming a principal and client manager at the firm.

She loved the Southern California weather and met her husband, Michael, while bicycling on the Peninsula. The couple have a son and a daughter, both young adults. Jill is the only non-engineer in her immediate family, but she is doing her best to cope!

#### **CRIME: SOLICITATION OF A MINOR**

**California SB 1414** introduced by Senator Shannon Grove, seeks to amend the current legal treatment of purchasing a child for sex by elevating it from a misdemeanor to a serious felony.

Under existing California law, the act of soliciting a child for sex is penalized lightly, with consequences ranging from two days to a maximum of one year in jail, alongside a fine of up to \$10,000. This leniency has raised concerns about California's commitment to protecting its children.

#### **FISA REFORM AND REAUTHORIZATION ACT OF 2024**

**H.R. 6611. Passed in Congress.** Under this bill, the U.S. government is granted broad latitude to surveil the electronic communications of non-U.S. persons located outside the country without requiring a court-issued warrant. Surveillance can include emails, phone calls, and text messages,

Section 702's provisions enable intelligence agencies to intercept the communications of foreign individuals outside the United States. This authority can inadvertently lead to the collection of communications that involve U.S. citizens.

Critics argue that this indirect surveillance effectively allows federal law enforcement to monitor the communications of Americans.
