IN SUMMARY, the Academy wishes to appoint the Reseller as the non-exclusive distributor of the Services subject to the terms of this Agreement.

THEREFORE, in accordance with the mutual promises and commitments of the parties, the parties have agreed as follows:

 Services Provided: The academy offers corporate academy services targeted at decision-makers; it particularly focuses on customized AI concepts and training based on specific pain points as mentioned above.

2. Role of the Reseller:

2.1 Reseller will promote the Company's services through word-of-mouth marketing methods.

- 2.2 Reseller may attend the trainings as an observer for educational purposes.
- 2.3 After gaining adequate knowledge and experience on keepgoin.AI trainings, the Reseller has the opportunity to establish its own branch under the Keepgoing.AI community anywhere in the World in any languages.

3. Referral and Commission Process:

- 3.1 Reseller will introduce potential customers to Dr. Keskin via email, WhatsApp group messages, or LinkedIn group posts who are really interested in.
