Supervisor Koehn opened the meeting with the Pledge of Allegiance to the Flag. Roll call was taken of the Board members present: Jim Malarney, Mike Herr, Steve May, Jim Koehn, Ray Thompson and Ben Ruesink. Rob Hosken was absent.

Ruesink moved, supported by Malarney, to approve the minutes of the Special Meeting held April 1st and the regular Board Meeting held on April 10th, 2021 at 7:00 pm. The motion passed unanimously.

Thompson moved, supported by Ruesink, to approve all the reasonable and customary bills and claim audit vouchers paid or presented for payment. The motion passed unanimously.

Chief Hanselman requested purchasing body cameras for the officers plus 2 defibrillators.

- **May moved, supported by Ruesink, to purchase 5 body cameras at \$400/each plus 3 kits to link to patrol cars at a cost of \$453 for a total cost of \$2,453.00.**
 - Paid from the Drug Forfeiture Account
 - The motion passed unanimously.
- **Malarney moved, supported by Ruesink, to purchase 2 defibrillators at a cost of \$2,442.78.00 each with a trade in credit of \$200 on the existing unit.**
 - One unit to be paid from the Drug Forfeiture Account
 - Second unit paid with General Township funds
 - The motion passed unanimously.

Old Business –

Scott Merrilat from the Lenawee County Road Commission stated the Road Commission DOES NOT support ORV use on public roads.

- Further discussion with the Planning Commission members and Supervisor Koehn will take place June 1st, 2021

New Business –

The Chair entertained a motion made by Thompson, supported by Ruesink to adjust ELECTRIC INSPECTION FEES as presented. The motion passed unanimously.


