Our Savior's Lutheran Church Endowment Fund Grant Application Guidelines

The Endowment Fund The OSLC Endowment Fund* is a restricted fund of Our Saviour's Lutheran Church (OSLC), located at 1200 N. Campbell Ave., Tucson, Arizona 85719. The Fund was established in 1986 upon receipt of an unrestricted bequest and is administered by the Endowment Committee in accordance with the Constitution and Bylaws of OSLC.

Purpose The purpose of the Endowment Fund is to enhance the mission outreach of Our Saviour's Lutheran Church. **Composition of the Fund** The Endowment Fund is comprised of the initial bequest and additional contributions (gifts, bequests, or memorials) that have been or may be added to the Fund from time to time, along with a portion of the earnings that accrue to the Fund through investment. Only income earned from the Fund, invested principal, is available for distribution each year. The award and amount of any grant shall be at the sole discretion of the Endowment Committee. Grant monies shall be paid directly to the congregation, agency, or institution designated by the applicant and agreed upon by the Committee.

Purpose of Grants Grants are intended primarily, but not exclusively, to enhance the ministries of OSLC and its broader mission, and may include benevolences, special projects, congregational or Synod ministries, community ministries and congregational capital improvements. Grants shall be made for specific ministries rather than to other institutions for their discretionary use.

Application Procedure Beginning in 2025, all requests for funding shall be submitted online by May 1 for consideration. The Committee will review grant requests and make decisions later in May.

Distribution of Grants The award and amount of any grant shall be at the sole discretion of the Endowment Committee. Grant monies shall be paid directly to the congregation, agency, or institution designated by the applicant and agreed upon by the Committee.
