REGISTRATION, MOTORCYCLE WAIVER AND EVENT RELEASE FORM

By signing this document, I represent that I am fully knowledgeable of the danger and hazards associated with riding motorcycles. I understand that such activities may cause serious injury or death. I certify that I am duly licensed and competent to operate a motorcycle in a safe manner and the vehicle is in a safe operational condition. I will be riding on public highways and am solely responsible to determine the speed and operational characteristics of my motorcycle while participating in the Ronald McDonald House Benefit Ride. Furthermore, I certify that I have liability insurance coverage as required by law for the vehicle used in this event.

I hereby release and hold harmless the Riders 4 Children and all their members in addition to Ronald McDonald House Charities of Southern Colorado from any and all claims for negligence, causes of action, or any other liability of any kind arising from my participation, during or after the Ronald McDonald House Benefit Ride and/or all event activities.

I certify that I have no known physical or mental impairments that may affect my safety or the safety of the group. I understand the choice of wearing a helmet or other protective gear is solely my own and I am responsible for my compliance with all state laws including the state helmet law. I certify that I am not under the influence of any narcotic, alcohol or other drug that may impair my understanding or judgment and I will not operate my motorcycle under the influence of same during the Ronald McDonald House Benefit Ride and event activities.

I consent and authorize the use and reproduction of any and all photographs and/or video that could be taken of me this day for any purpose, without compensation to me or my assignees. All images, digital files, and videos are owned by the Riders 4 Children, who reserves the right to use those images, digital files, and/or videos for online or printed publications at their discretion. In the event my passenger is a minor, by signing below, I consent and authorize to the same conditions listed above for them.
