## **Background Information**

*Do you have a disability that keeps you from working? Did you know you may be entitled to benefits?*

*Have you been denied disability or SSI benefits by the Social Security Administration?*

### **Did you know?**

- Many individuals who apply for Social Security benefits simply do not understand the application process or how to complete the complex forms involved in the Social Security benefits process.
- People who are denied benefits at the initial or reconsideration level have a significantly better chance of obtaining benefits with a qualified representative.

### **How can a qualified representative help win your claim?**

A qualified representative can help you obtain benefits you may be entitled to by:

- Helping you determine your “Alleged Onset Date” (AOD), an important date in your claim.
- Obtaining relevant medical records from your treating physicians.
- Requesting a functional limitations form be completed by your treating physician. This will indicate what you can and cannot do in the areas of sitting, standing, walking, lifting, concentration, attention, etc. This is important information Social Security uses in determining disability.
- Ensuring that all deadlines and appeals are met so you have less to worry about.
- Ensuring your entire case is presented to the Social Security Administration.

### **You need a representative who:**

- Will work as an advocate for the most important person in the process:  
**YOU!!**
- Can communicate effectively with Social Security staff, administrative law judges, physicians, and other medical providers.
- Is knowledgeable and experienced in dealing with a wide array of medical conditions and disabilities.
- You can access directly. I will answer your call personally or return your message within 24 hours.
