~Restrictions and Damages~

Your party bus has been inspected by your driver and our management prior to your engagement. Prior damage has been noted and recorded for your protection and safety. You, the customer, are encouraged to inspect and confirm the condition of your party bus prior to use. This bus will be re-inspected upon conclusion of your engagement, by yourself, and out your party bus staff. You will be charged for all repairs and unusual cleaning that was caused by you or anyone in your party.

READ AND INITIAL BELOW

SUNROOF / WINDOWS

For your safety, we ask that **ALL BODY PARTS** remain inside the passenger cabin at all times while the vehicle is in motion. No standing or hanging out of the sunroof or windows

MINORS

Special laws apply while transporting passengers UNDER 21 YEARS OF AGE, Section 5384.1 and 5384.5 of the Public Utility Code. In brief, these laws require our drivers to ascertain identification. If any passengers are under 21 years of age, the driver must read a statement advising that ' [REDACTED] IF SO, OUR SERVICE WILL BE TERMINATED IMMEDIATELY. THE CUSTOMER AND PARTY WILL BE RETURNED TO THE POINT OF ORIGIN. YOU WILL NOT BE REFUNDED.

SMOKING

Smoking is prohibited inside the vehicle. [REDACTED]
If you are caught smoking in the vehicle, you will be charged a \$250.00 refresh fee and a \$400.00 fee for each burn in seats, carpet, headliner, or any other place in the vehicle.

VOMITING

Vomiting in the vehicle will be a \$400.00 fee. This fee is necessary due to the costly cleaning and vehicle down time. The driver will gladly pull over when safe to do so.

DELAYS

We, The SLO Party Bus, are not responsible for delays due to passengers being late, heavy traffic, accidents, missed flights, bad weather or any other natural disasters.

PERSONAL PROPERTY

We at The SLO Party Bus ARE NOT RESPONSIBLE FOR ANY FORGOTTEN, LEFT, LOST OR STOLEN ARTICLES IN THE VEHICLE AT ANY GIVEN TIME.

FIGHTING AND/ OR ILLEGAL SUBSTANCES

We have [REDACTED] In any such case that either of these become an issue, your entire party will be dismissed at the location of the incident and [REDACTED]

I understand and agree to all of the above terms and conditions. I understand that the driver has the right to terminate the ride if anyone becomes to rowdy or unruly. None of the money will be refunded. If I or anyone in my party should default on any of the above terms of conditions, the rental agreement will be terminated. By signing this contract I am agreeing that if anyone is injured under any circumstance, myself and any or all passengers boarding the bus can not hold SLO Party Bus responsible. There are no seat belts on the bus. All passengers ride at their own risk and carry full responsibility and liability for any injuries that might occur on or off the bus. SLO Party Bus is not responsible for any accidents, falls, or injuries and carries no responsibility or liability.

I TAKE FULL RESPONSIBILITY FOR ANY AND ALL CONTRACTED COSTS, DAMAGES AND ALL COLLECTIONS FEES TO RECOVER FEES CAUSED BY MYSELF OR ANYONE IN MY PARTY.
