The 14th Amendment Has Never Existed — This Lawsuit Aims to Prove It

“FILED IN THE D.C. DISTRICT COURT AND U.S. SUPREME COURT, THIS NATIONAL CLASS ACTION DEMANDS AN IMMEDIATE NATIONWIDE COURT SHUTDOWN ON CASES WHERE UNREPRESENTED LITIGANTS FACE REPRESENTED OPPONENTS — AND CALLS FOR STRUCTURAL JUDICIAL REFORM.”

Dr. Daniel J. Feldman, a disabled federal whistleblower and civil rights plaintiff, has filed a national class-action lawsuit alleging that **America’s courts function as a two-tiered system** that favors licensed attorneys and blocks access to justice for everyone else. The case demands a **nationwide freeze** on all proceedings where pro se parties face attorneys, until procedural parity is restored.

Feldman’s filing documents how every federal and state court enforces **published rules** that discriminate against unrepresented parties — including:

- Paper-only filings limited to business hours
- Clerk gatekeeping of pro se filings
- Denial of access to class actions or Supreme Court petitions unless represented
- No meaningful consequences for attorney misconduct, perjury, or abuse of process

“Judges, clerks, and attorneys aren’t neutral — they’re work colleagues,” said Feldman. “The unrepresented party is always the outsider, treated as a threat to the system, not a participant in it.”

Feldman’s personal case shows the stakes:

- **Fraud** — A jury found his former boss guilty of theft and abuse. He faced no jail time.
- **Murder** — Feldman’s partner was killed by a narcotics manufacturer. He was blocked from filing wrongful death claims.

- **Slander** – Courts acknowledged he could sue for \$1M but blocked evidence and imposed \$500K in sanctions.
- **Eviction** – On May 27, 2025, Feldman was forcibly evicted. Deputies unplugged his camera and removed every belonging.



He is calling for **federal prosecution of deputies and court actors** under hate crime statutes and “color of law” violations.

“This lawsuit asks whether the Constitution protects everyone — or just those who can afford counsel.”
