Dear LMPD Records and MetroSafe,

Under Kentucky's Open Records Act (KRS 61.872), the required response time for body cam and dispatch records is five business days. Your response of over 28 days for standard records—where I am the subject, no redactions should be required, and the data is urgent for a Supreme Court filing—raises serious concerns about transparency and preservation.

I am formally requesting immediate compliance with the five-day statutory timeline. If there is any delay, missing data, or evidence of records being withheld or compromised, I will ask the Kentucky Attorney General's Open Records Division to intervene and oversee the request—just as I have requested with the Sheriff's Office.

This is an urgent matter, with evidence needed for a Supreme Court of the United States filing by June 30th.

Please confirm, in writing, that all records will be produced without delay or redaction, or provide a specific legal basis for any exception. Again, body cam and dispatch records should not require any editing or reaction and should be handled easily within the standard 5-day window.

**This is a formal, multi-agency open records request, criminal referral notification, and demand for immediate oversight, submitted in accordance with the Kentucky Open Records Act and federal FOIA.**

### Background and Basis for Oversight

- The Jefferson County Sheriff's Office and U.S. Marshals Service have both been formally served and notified via filings to the Supreme Court of the United States of a criminal referral for their participation in a hate crime resulting in physical injury and permanent loss of eyesight.
- This hate crime—documented in sworn affidavits, federal court, HUD, and Supreme Court filings—involves three years of retaliation and exclusion, denial of due process, and unlawful evictions targeting a disabled, LGBTQ whistleblower.
- Under Kentucky and federal law, these hate crime offenses carry **mandatory jail time with no parole** for all participants.
- This request must be overseen by the Attorney General's Office and DOJ/USMS, due to direct, personal, and criminal conflict of interest.

**I am including here a copy of my open records requests to LMPD and MetroSafe regarding the false 911 calls, and the request for all body cam footage and dispatch records involving the false 911 call that led to the unlawful trespass and endangerment of two senior citizens.**

### Special Note on the False 911 Call (May 23, 2025)

The false 911 call on May 23, 2025, was especially egregious and dangerous:

- It resulted in armed on-duty LMPD officers being sent to confront off-duty police officers who were en route (at my request) to guard my property after my apartment's locks were illegally removed, leaving my home and belongings unprotected.
- The call falsely accused two senior citizens—one 81 years old on a walker, the other over 70—of being armed and dangerous, when in fact they were only present to help pack up artwork and posed absolutely no threat.
- This action not only led to their unlawful trespass from the premises but created a lethal situation for both police and civilians, and was intended to further isolate, endanger, and punish a disabled and whistleblowing tenant.
