### America's Courts Shut Out Millions—Class Action Seeks Participants Denied 1st, 5th, and 14th Amendment Rights

**"IF YOU'VE EVER BEEN BLOCKED FROM JUSTICE OR IGNORED BY ANY COURT, AGENCY, LEGAL AID, OR 'WATCHDOG,' THIS CASE IS FOR YOU."**

Who Can Join This Class?

- Anyone **denied the right to file, respond, or be heard in court** because they didn't have a lawyer.
- Anyone **refused e-filing, blocked by clerks, or forced to file in person** while attorneys got special treatment.
- Anyone whose **constitutional rights—the right to speak, the right to a fair chance, the right to equal protection—were ignored** by the courts or anyone in power.
- Anyone **denied ADA accommodations** or help for their disability.
- Anyone who **tried to report a problem or corruption**, but was ignored, blamed, or shut out

#### *First Amendment*

*... the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.*

#### *Fifth Amendment*

*No person shall be... deprived of life, liberty, or property, without due process of law...*

#### *Fourteenth Amendment*

*...nor shall any State... deny to any person within its jurisdiction the equal protection of the laws.*

#### **First Amendment – Right to Petition:**

*You have the right to ask for help in court, speak up, file a complaint, or report wrongdoing. No one can block you just because you don't have a lawyer.*

#### **Fifth Amendment – Right to Due Process:**

*You have the right to a fair process before you lose your home, property, freedom, or safety. The court must give you notice, a real chance to respond, and actually look at your evidence.*

**Right to a Fair Hearing:**

*You deserve a real hearing—not just to have your papers tossed or ignored. Judges and clerks can't block you because you represent yourself or have a disability.*

**Fourteenth Amendment – Right to Equal Protection:**

*The law must treat everyone the same—no matter your race, disability, income, background, or whether you have a lawyer.*

**ADA – Americans with Disabilities Act:**

*If you have a disability, the court **must** help you (extra time, remote appearance, letting a helper speak, etc.). It's illegal to ignore this.*

**HUD – Housing and Urban Development:**

*HUD is supposed to protect your housing rights. If you lost your home because of discrimination, this case is for you.*

**This Case Is Also for Anyone Ignored by “Window Dressing” Agencies**

- If you ever asked **HUD**, the **Human Rights Council (HRC)**, the **Office for Civil Rights**, or **Health and Human Services** for help—and got nothing but a form letter or “case closed”
- If you reached out to so-called legal help or advocacy groups—**Eviction Defense Collaborative**, **AIDS Legal Referral Panel**, **legal aid clinics**—and they refused to help, sided with the landlord, or simply disappeared
- If you contacted an **ombudsman**, **patient relations**, or **patient advocate** and they just protected the hospital or the agency—not you
- If you went to the **Controller's Office**, **mayor's office**, or **district attorney** and nobody cared, nobody investigated, or you were blamed
- If **law enforcement** treated you differently, refused to investigate, or only enforced orders for those in power—not the public
