"I am calling to demand an audience for my friend Dr. Daniel Feldman with David Anderson US District Attorney regarding investigations into corruption at the Department of Building Inspection and the SFPD and collusion with the Mayor's Office, Controllers Office, Commission for the DBI, and the Board of Supervisors. For two years, he has notified local law enforcement, politicians, and watchdog groups, including the FBI field office. Not one of those groups has listened to Dr. Feldman's story or reviewed his evidence, which he alleges includes recordings of bribes with City Officials and other evidence linking members of the SFPD to a narcotics operation that has continued for 20 years in his affluent neighborhood of Duboce [doo-BOSE] Triangle. Your office will not allow him to speak to Mr. Anderson unless he goes through the FBI, yet the FBI hangs up the phone and refuses to discuss or review his evidence for no given reason. Dr. Feldman went on a hunger strike on July 13 with specific demands to speak directly to David Anderson and has not heard from him. He was chased off the Federal Courthouse property by Department of Homeland Security. Please have him call Dr. Feldman today at 307.699.3223. He is waiting for his call. Thank you."

## BACKGROUND FOR DISCUSSION WITH ANSWERING PARTY

David Anderson's office, despite calling for citizens to come forward with any information about local corruption in San Francisco, has refused to discuss this with Dr. Feldman unless he goes to the FBI. Despite reporting 4 times to the FBI, they have hung up the phone on him or refused to meet him in person. Until David Anderson agrees to meet with Dr. Feldman and open an investigation immediately into these issues, he began a hunger strike protest on July 13 and has not received any communication on your behalf.

Until these investigations are underway and evidence Dr. Feldman has is reviewed with him and others who come forward with an agency who will have not only the ability to investigate but to present them before a power able to enforce accountability, and until the city adopts an ordinance effective immediately requiring mandatory reporting of corruption, Dr. Feldman claims that he will not eat but only consume liquids with electrolytes. He has discussed this with his physician and has agreed to weekly if not daily monitoring of his constitution as he fasts in protest. Dr. Feldman has also agreed to a mental health evaluation and daily drug testing, if necessary, in the event that anyone wants to claim that his story is a product of substance use or a delusion. The only medications or procedures Dr. Feldman says he will allow during the fast are palliative.

I would be so appreciative if Mr. Anderson will end Dr. Feldman's fast and meet with him or call him. I have to believe that others in his community have faced similar stonewalling by the SFPD, DBI, Mayor's Office, or any of their respective Watchdog agencies, and maybe even their lives have been as ruined or threatened as Dr. Feldman's has been. We need your strong leadership to end this corruption and preserve everyone's rights to freedom and the pursuit of happiness as guaranteed in this country. We elect and pay these government leaders like yourself and the local bureaucracy with our tax dollars and many of them have forgotten who they serve, and it is not their campaign contributors or other pocket liners.

I beseech you to open a conversation directly with him, and personally review his claims and evidence as well as his proposed ordinance for mandatory reporting of corruption. You can call him directly at 307.699.3223. Thank you.

## HUNGER STRIKE DEMANDS

In addition to a live discussion with Mr. Anderson, Dr. Feldman made the following demands:

- 1 The city must **open an investigation into police corruption** regarding the protection of the narcotics manufacture and distribution from his residence at 884-886 14th St, led by his landlord, Linda Steinhoff Holmes, Curtis Holmes, and James Severance, and hold all parties found guilty of corruption laws accountable with prison and fines to the full extent that the law allows, barring any members of the SFPD involved from returning to a career in law enforcement.
- 2 The city must **open an investigation into corruption at DBI** as it relates to covering up violations at 884-886 14th St, and fraudulently abating cases that have not been completed or without an inspection, and hold all parties found guilty of corruption laws accountable with prison and fines to the full extent that the law allows, barring any DBI or public employees involved from ever holding office or a role paid in part from taxpayer money
- 3 The city must **open an investigation into unlawful landlord lawyer practices that encourage perjury** to hurt their tenant defendants' reputation and to settle for less money than they deserve, particularly to evidence in Dr. Feldman's case which implicated current or former legal counsel of Linda Steinhoff Holmes, up to and including the murder of Christopher Hefner and Dr. Feldman's attempted murder and hold all parties found guilty accountable with prison and fines to the full extent that the law allows, barring any attorney from returning to practice as legal counsel.
- 4 **A new city ordinance is adopted requiring mandatory reporting of all claims of corruption**, that is, if you are an elected official and or your salary is paid for in part by tax funding and you are made aware of corruption by a citizen, that you have 24 hours to report that to a whistleblower agency, and failure to do so will result in the prohibition of holding public office or in a role as a public servant in the future, ever. And if instead of reporting, upon hearing a citizen's report of corruption you choose to discredit or silence the source of the complaint, as has been done repeatedly to Dr. Feldman, additional fines and penalties will be added.

## BACKGROUND OF DR. DANIEL FELDMAN

Dr. Feldman is a federal whistleblower prevailing at the US Supreme Court in 2012 after a 13 year qui tam against Cornell Medical University where he completed his postdoctoral fellowship in clinical neuropsychology. To read more about that case:

Dr. Feldman has been a licensed psychologist for over 20 consecutive years without incident and the extent of his legal history amounts to a speeding ticket for 5mph over the speed limit near Princeton NJ over a decade ago. He has no history of assault or violence and yet has been falsely accused now of multiple acts of violence, listed as a terroristic threat, and banned from his medical providers and a couple hospital systems in San Francisco where he had been receiving medical care for a serious medical condition. He has been denied any chance to appeal these decisions or even present his account of events that led to their decision.

Before moving to San Francisco, Dr. Feldman has held key senior management positions working on both the clinical and commercialization divisions at pharmaceutical manufacturers, including Forest Laboratories, Novartis Pharmaceuticals and Bristol-Myers Squibb. He also held a faculty position for years at Rutgers School of Business teaching Pharmaceutical Marketing and have served 7 elected years on the board of Pharmaceutical Management Science Association holding the position of president for two separate years. Dr. Feldman has received numerous awards, including outstanding graduate research award from the APA, the President's Award at the manufacturers where he worked, and in 2011 was recognized as Pharmaceutical Marketing Researcher of the Year from the Pharmaceutical Marketing Research Group, the gold standard industry association.

# FULL DESCRIPTION OF EVENTS IN SAN FRANCISCO AS ALLEGED BY DR. DANIEL FELDMAN

My life and freedom are on the line regarding a serious problem in San Francisco. Below is an accurate account of events as I experienced them:

- My landlord, Linda Steinhoff Holmes, her husband, Curtis Holmes, and upstairs neighbors, James Severance, Reggie Snowden, Sean Tracy, and Jazmin Ruiz, in the two other apartments have been involved with a clandestine narcotics manufacture and distribution operation at the corner of 14th St and Noe St for more than 20 years

- In May 2017, I recorded a bribe between my landlord's representative, Robert Noelke, and two Department of Building Inspection inspectors directly under my front door security camera and a sign saying "This Area Is Under Surveillance"

- In December 2017, I inadvertently discovered the narcotics operation when PGE showed me where my landlord and her husband had diverted electricity from my fusebox so I was paying for her office, common areas, her privately rented garage, and upstairs two apartments' front rooms. I hired an independent electrician from Bay Electric to cut the line and verified the energy theft which is a felony.

- The SFPD made a report when inspecting the added electric lines, confirmed that it was a felony, and said the District Attorney would not prosecute it unless I had a report from DBI that stated that electrical work had been done without a permit. Inspector Overstreet told me that the only instance of when someone would risk a felony to commit energy diversion would be when there was illicit drug manufacturing on the premises and they want to hide their energy usage from law enforcement. He told me to keep a lookout for other signs of activity and to report it to the Narcotics Division.

- In late December 2017, after recording on my security camera multiple cars coming in and out of the garage almost incessantly during the hours between midnight and 6am for almost a week, I called the Narcotics Division of the SFPD around 1am. Instead of opening an investigation, they alerted my landlord and neighbors of a report and potential raid. Within hours of making my report, they removed the house numbers from their front door, and my landlord and 4 or 5 other cars including a US Postal Truck showed up before dawn and began removing equipment and other material from the premises.

- Around the same time, an inspector, Michael Bain, arrived from DBI to look at the energy diversion that had been documented with consent on video and in written reports from PGE, Bay Electric, and the SFPD. The inspector refused to look at my fusebox, any reports, or videos with PGE, Bay Electric, or the SFPD. He said, "I see nothing, Sir," turned his back on me and walked away unresponsive. The SFPD then told me that without the DBI inspector's report, there was nothing they could do as the District Attorney would not be interested in pursuing it.

- I wrote dozens of letters to our District Supervisor Rafael Mendelmann, our Park District Police Captain Una Bailey before she left her post in December, the Chief of Police Bill Scott, the Department of Police Accountability investigators Susan Gray and Brent Begin, the District Attorney's Office, the City Lawyer, the Controller's Office Whistleblower Program investigators Matt Thomas and Dave Jensen, all up through the chain of command at the Department of Building Inspection to Taras Madison, Jamie Sanbonmatsu, and Tom Hui before he resigned in February, Vice President of the Commission for DBI Debra Walker, Neighborhood Liaison Services Director Alex Lazar, and the Mayor London Breed herself. Not one of them has been interested in my report about corruption at DBI or the SFPD. In three years, none of these local politicians has been willing to sit down and listen to a recording of the bribe with two DBI Inspectors or look at my evidence for energy theft. No one will seriously investigate the narcotics lab at my residence at 884-886 14th Street, yet my landlord and upstairs neighbors are fully aware I have made these reports, which puts me in grave danger.

- My landlord has since began telling neighbors, guests that visit my home, police officers without going as far as to make an official report, maintenance workers on the property, my health care providers, potential roommates, and nearly anyone who will listen to her on the street that I engage in elder abuse, that I have threatened her with a gun, with a machete, that I have physically attacked her and had to have others pull me off of her. None of these stories are true, there are no police reports, I have never been charged, there are no witnesses other than her employees in the upstairs two apartment who were coached by their legal counsel, possibly Daniel Bornstein as he represents her now as she has taken me to court repeatedly during this Covid nightmare to have me evicted on these false claims of violence. I am a specialist involved primarily with geriatric care, and it is so offensive to me that my landlord has been able to convince people that I engage in elder abuse, something that couldn't be farther from the truth. I have no history of violence, no criminal record to speak of, and I have been licensed consecutively for over 20 years without a blemish on my record

- UCSF risk management sent me a letter canceling all of my future doctor appointments after hearing that I engage in elder abuse, and as I have a serious antiinflammatory/antiimmune disorder that needs close monitoring, the loss of my doctors was severe. When I called UCSF Risk Management, the attorney I spoke with on the phone told me that she had personally spoken with my landlord and that I get no appeal as the have a ZERO TOLERANCE policy for violence, claiming she would not even read an appeal from me if I sent it to her.

- In May 2019, my roommate, now inconveniently deceased, and I clearly overheard a loud conversation between three of employees of the landlord and a Legal Expert on a conference call by speakerphone. At the time, I believed the Legal Expert was an officer at the SFPD who has consulted with them in the past and now believe it was someone on their legal counsel, provided clear consultation about three key elements of a conspiracy plot to accuse me of an assault on Mr. Severance with the outcome of having me arrested under false charges: 1) there would be a friend- or self- inflicted wound on Mr. Severance, which upset Ms. Cruz (alias?), 2) they and the landlord and her husband needed to be tightly uniform in bearing false witness against me to the responding officer from the SFPD, and 3) there was an object of some kind that needed to be planted on the premises or in my apartment that would be the proof

that I indeed had been responsible for the violent threat or other crime. I could not see the object that they were discussing that they had in their possession at the time, but it was clearly something like an unregistered gun (I do not own a gun of any kind), or a registered gun with a body count, or narcotics. Whatever it was, the Expert they were consulting on the phone was impressed that they had obtained it and agreed with them that it was perfect for the plot to work. They intended this event to take place at a time when I would need to appear before court for Eviction, and as I would be in jail on these false charges, they would win on default or summary judgment without ever having to testify. I alerted my landlord and Mr. Bornstein that we overheard and recorded this conversation and had made reports to the SFPD and District Attorney.

- In December 2019, exhausted after repeatedly trying for over two years to get someone to investigate the bribes at DBI, the energy theft, and the corrupt members of the SFPD who supported this narcotics ring, I wrote to the Mayor, the head of DBI, the Controllers Office, and all of the local news media who had been unresponsive thus far, that I intended to go on a hunger strike at City Hall demanding those 3 investigations: 1) bribes at DBI, 2) energy theft, and 3) corruption in the narcotics unit of the SFPD. In addition, I also demanded that the city adopt a law regarding mandatory reporting of corruption.

- The day after sending notice of the hunger strike, I received an Unlawful Detainer from Daniel Bornstein demanding my eviction on the grounds of repeated threats and acts of violence on the property, including threatening my landlord with a gun, a machete, and physically attacking her, as well as vandalism and nuisance allegations, all false.

- Around the same time, I noticed my water changed appearance to a milky white and left skin abrasions and burned. This was only the hot water at first, and when the water department came to evaluate, they would only test the cold water. My roommate had just been diagnosed with Non Hodgkin's Lymphoma at the age of 39. And with the water change, we all got sick with infections. Because of his infections, they were unable to ever start chemotherapy, and it metastasized quickly. He died on March 21st.

- Part of the fraud with DBI inspectors includes their refusal to report an increasing mold issue in my apartment due to a continuous water leak from one of many water tanks in the apartment above me. This continued for over 18 months, with 4 inspections where the inspectors commented on the severity of the mold in my apartment, saw and felt the water on the walls and on the carpet, in addition to increasing water stains down the freshly painted room. Despite pointing out the obvious issues to me when doing the inspection, each report would say there was no evidence for a water leak or mold, blatant lies manufactured I have no doubt due to influence from my landlord like I recorded in May 2017.

- The day after the most recent DBI fraud in January, I hired a certified environmental specialist, ERT lead by Mr. Richard Fanelli who has over 20 years experience, to test the air and water in my apartment. He took air samples showing extreme levels of toxicity from mold spores from two species of mold. He commented that for DBI Inspectors to have reported no evidence of mold or a water leak was either gross incompetence or collusion to be reported to DBI management.

- Mr. Fanelli also observed the hot water abnormalities that I had tested earlier that week to find the pH was less than 4 (very acidic) and had the presence of E. Coli bacteria, explaining our illnesses. He only did a repeat test for E coli which was absent in his sample, but he remarked that clearly there seemed to be a contaminant in the water. And he observed what I did as about a dozen witnesses in total: when the hot water was turned on, no matter which hour, you could hear someone running from wherever they were in their apartment to the room above my shower where my hot water source is and to which I have no access. And you could hear them switch a pump of some kind on. And it was clear. And I began recording this, turning on the hot water at all hours of the night, and even at 4am, someone would come running, sometimes multiple people, and they would switch on a pump, and my water would turn milk white with a scum floating on top of it. I have asked to see my new hot water source, the landlord refuses to respond at all, nor does her attorney Mr. Bornstein, that the water has not been potable since the end of December. And the contamination is nothing short of poison. Two guests were sick and hospitalized, my cats were sick, and I have had more than a dozen doctor appointments and follow-ups, 4 emergency room visits, a couple urgent care visits, and I already mentioned that it prevented my best friend from getting needed chemotherapy, and he died an untimely and wrongful death on March 21.

- I have brought this to the attention of the SFPD at Park Station, and the officer laughed at me and told me to leave the station. He refused to look at the report from Mr. Fanelli, my videos of the issues with water and mold, or review any evidence I had. This is the same response I have had from the SFPD in the seven years prior, who seem eager to protect my landlord despite insurmountable evidence of them harassing and threatening me. I cannot go into all of the episodes here but needless to say I have over 25 police reports for harassment and violence against me, and the SFPD have yet to assign an investigator after I have asked each time, including: my assault from 3 armed men in front of the apartment who blinded my left eye; my cats being poisoned with cat food that is not their brand that was in the apartment; the death of my cat and my hospitalization after a carbon monoxide leak with no CO detectors in the apartment; bag of rotting meat with maggots put in my living room (I am vegan); my landlord stealing my patio furniture while the dispatched officers I called watched and allowed her to do so; an officer pulling me out of my home naked and leaving me on the porch with no way to get back inside, no phone, no wallet, in the cold February rain covered in mud on the porch for nearly an hour before a neighbor called the fire department to help me get inside. I have written Chief Bill Scott nearly a dozen times about this without a single response. I have been to the Department of Police Accountability several times and they refuse to investigate any of this although I sat in their office for over two hours just getting through a couple of incidents. Needless to say, the SFPD need a massive reform, and I am encouraged about the protests going on. I feel that more peaceful protests are still needed, like the hunger strike I planned in December. They have done me a huge injustice and there is no doubt in my mind that some of the officers are rewarded for protecting my landlord's narcotic business for which there has yet to be a serious investigation.

- Currently, I am facing eviction, and during this Covid nightmare, it has been impossible to find legal representation, and I have exhausted every channel. The Eviction Defense Collaborative, tasked with providing attorneys to those facing eviction as guaranteed by the city, was initially helpful and there are some extremely



hard working and compassionate individuals there. However, it is led by management who could care less about their clientele and only want to move the needle of the number of tenants served regardless of who they assign or what the outcome is. I was assigned a lawyer at ALRP who was initially helpful, yet had to leave due to a family illness just before the Covid nightmare. The replacement attorney was unethical, unsupportive, had limited and almost no experience in tenant-landlord court. It is too long to get into here, but she did far more harm than good in her short tenure on my case before I fired her. And the EDC refused to assign another attorney to me despite their first assignment being an utter waste of time, harmful to my case and restoring habitability, and left me unrepresented at a time when no attorneys I contacted were taking new clients due to Covid. There has been a stay on Evictions, as you may have heard, but that does not apply to Evictions where violence is alleged to be the reason for the Eviction. So I have had a half dozen hearings in court, all orchestrated by Mr. Bornstein with made up stories of assaults by me on the landlord every week, and me having to defend myself without an attorney. The court resources for disabled persons like me are completely absent. The court self-help for defendants representing themselves are non-existent. And every time I ask the court how to do something, or where to file things, instead of an answer, I am simply told it is inappropriate communication with the court. According to the law, self-represented parties should not be disadvantaged versus those with legal counsel, but that has not applied during this Covid nightmare for me, and my housing, livelihood, and even freedom are at risk as my narcotics manufacturing landlord claims new episodes of elder abuse every week, even when I have been in the hospital and sick.

- I have not been able to live in my home for nearly 6 months with my two cats unfairly dragged around. I have spent more than \$20k in hotels and AirBnBs since December, dealing with putting my best friend in hospice, his death quickly following, fraudulent DBI inspections, an onslaught of court motions and appearances over multiple fake claims of assault, my having to see doctors weekly, finding someone to go into my home to get any of my stuff there that is all covered in mold and worsening.

- I cannot be alone anywhere near my home, as my landlord claims I have attacked her and had to have her husband pull me off of her. To be clear, I have seen my landlord one time in two years, and that was earlier this year when on the sidewalk I gave her my keys to get into my apartment when she claims her keys were stolen and was going to drill out the keyholes at my own expense.

## ENOUGH IS ENOUGH

The SFPD is corrupt and will not help. The DBI is corrupt and will not help. The Rent Board claims that despite my environmental reports, they have to go by whatever DBI says as the final word. And if I think there is fraud, I have to prove that first before going to the rent board for help. Because of Covid, I cannot sue for lack of habitability because the courts are closed for that. However, I am in court for Eviction unrepresented against a lawyer who I strongly suspect is the expert who guided my landlord and her employees to make false police reports about violent acts they would claim against me, guided them to perjure declarations and statements against me in hopes to win the Eviction on a technicality or by default. In that way I would lose and they would never be subpoenaed or deposed or held accountable for these actions at all. And my freedom may be at risk for false allegations. And despite years of collecting hard evidence, not a single local watchdog group, law enforcement group, or member of our local bureaucracy have been willing to do anything at all.

In my humble opinion, they should all be fired, from the Mayor, to the Chief of Police, everyone at the watchdog groups which are more like watchslugs (Debra Walker, Matt Thomas, Dave Jensen, the District Attorney, Rafael Mendelmann, Susan Gray, Brent Begin), everyone at DBI as I found collusion and cover up all the way up to Tom Hui, and his deputies Taras Madison and Jamie Sanbonmatsu, and especially inspectors who committed fraud, Jose Lopez, Alan Davison, Christina Dang-Moy, and Michael Bain. Our local news media I have lost utter faith in their reporting as they have consistently ignored my requests for help for years: shame on them for claiming to uncover local corruption when their stories are cherry-picked and not ones that include a cover up of a narcotics operation a block from a public school in Duboce Triangle that has been in operation for 20 years, well-protected by the SFPD and well-covered up by DBI.

## THE FISH ROTS AT THE HEAD

Corruption like this can only be as pervasive as it is when it lives in a system that supports it, from the top to the bottom. If the Mayor had responded to my claims of corruption, it would not survive. When our leaders turn a blind eye at best, or spend effort trying to discredit the source who is reporting corruption, at worst, either way it is collusion and they are all responsible.

If you have been discouraged by similar stories of corruption, please reach out to me. I would love to know your story and add it to a growing collective, demanding change from the top down. If you know anything about the disgusting narcotics operation at my address, I would love to hear from you so I can add your information to a growing set of knowledge about who is involved, which of the SFPD have been involved in protecting it, and to hold them responsible for bribing the DBI, making our neighborhood unsafe.

Until my life and freedom had recently come into jeopardy, I did not quite understand how pervasive the corruption in our local bureaucracy was, and how seriously it is kept a secret from most who have not directly experienced it. People will and have resorted to murder to keep this secret. My best friend is dead, and I am hunted.

I am not going to tell you to believe me. Please question everything, and not just what I relate to you in this post, but question what you are told by the police or any government official who says anything about my story. I will tell you that I have a long history of standing up for the truth, even when it is extremely uncomfortable to do so and when most others backed down. I was the only witness to come forward to fight corruption I had witnessed at the National Institute of Health and Cornell University Medical College in Manhattan where I completed my postdoc only to spend the next 13 years in court all the way to the US Supreme Court where I prevailed in 2012, proving the corruption as just one person to stand up and tell the truth. I got death threats after that and moved to San Francisco in 2013. And what I have encountered and the threat that is currently on my life and freedom is far worse than anything I experienced before.

It may sound like a work of fiction or delusion or bad dream, and I wish it were as simple as waking up from a nightmare. I have evidence to back up all of my claims, and already this post is too long. I am happy to share what I have with anyone who wants to know. My goal is to get my neighbors who are also at risk from devastating consequences of this corruption to question those in charge who I have listed above.
