

THE CITY COUNCIL CONVENED IN A REGULAR MEETING IN COUNCIL CHAMBERS, LOCATED AT 12288 E. HWY 190, KEMPNER TX 76539.

1. CALL TO ORDER, INVOCATION, AND PLEDGES TO FLAGS

The meeting started at 6:05 PM. The quorum consisted of David Richardson (place 1), Dan Long (place 4), Debbie Hernandez (place 5), and Mayor Wilkerson. Tom Combs (place 2), Rob Green (place 3), were not present and had provided prior notice to the city of their absence. David Richardson led the invocation.

- Fire Chiefs Report- Presented by Chief Connie Green See attached.
- Police Chief Report Presented by Chief Heriberto Rodriguez-Chief Rodriguez stated for the month of December there were 60 traffic stops that resulted in a warning or citation. He also stated Peace Officer Aspen Walker has submitted his resignation effective February 1, 2024, and the Kempner Police Department will sponsor two individuals for the upcoming police academy.
- Mayor's report- Presented by Mayor Wilkerson- Mayor Wilkerson stated we are in the process of reviewing bids for repairs to CR 3300. He also stated that he was contacted by two citizens regarding the pothole in front of the new Family Dollar/Dollar Tree Combo. Mr. French was contacted, and the repair was completed promptly.

A. Approval of the Quarterly Investment Report for the fourth quarter.

Hayleigh Talasek the Investment Officer stated that the Quarterly report was as follows:

- The first column is all bank account balances as of December 31, 2023.
- The Second column is all bank account balances as of December 31, 2022.
- And the third column is the difference between the two years.

Mayor Wilkerson added the council ordered that the city have a 180-day reserve fund in the 2022/2023 budget. The city has exceeded that amount, and the 180-day reserve fund has been allocated. Mayor Wilkerson also added he and the city manager would be working together to bring the money that is more than the six-month savings to the council for allocation into whatever the council decides whether it be infrastructure, capital outlay or otherwise.

David Richardson (place 1) made the following motion: <u>to approve the investment report</u>. Seconded by: <u>Dan Long (place 4)</u>.
All in favor, motion passed by all present.

B. Approval of Resolution No. 2024-01-09-001, A RESOLUTION FOR THE CITY OF KEMPNER, FOR PORTABILE HANDHELD RADIOS.

Mayor Wilkerson stated he would be discussing both action items B & C together, but they will need independent motions. Mayor Wilkerson turned it over to Mrs. Ramos the City Manager to explain why we are revisiting these resolutions. City Manager Ramos stated during the grant process there are a lot of steps. They (Grant Managers) request ordinances, resolutions, policies, etc. Once you submit requested documents, they return feedback. The new reviewer on these grants wanted a wording change from "The City of Kempner" to "The City Council of the City of Kempner" since it is the City Council that is approving the resolutions. In conclusion they are the same resolutions just with that specific wording to meet her criteria.

Dan Long (place 4) made the following motion: <u>To approve resolution No. 2024-01-09-001.</u> Seconded by: David Richardson (place 1)

The motion was made as follows: All in favor, motion passed by all present.




