B. Receive presentation and accept the Annual Financial Report for The City of Kempner, Texas ended September 30, 2021, commonly referred to as the FY 20-21 Audit.

Jon Watson (CPA with Brooks, Watson & Co.) presented the findings of the financial report for the fiscal year 2020-2021 Audit for the City of Kempner. Mr. Watson explained our mixed audit opinion as follows: The city received a disclaimed audit opinion with an unmodified opinion over the statement of net position and balance sheet. Mayor Wilkerson asked for clarification on whether the city furnished all documents requested. Mr. Watson replied he had not received all the requested documents but felt that the city in good faith provided all documents available. Mayor Wilkerson wanted it on record with the council that our staff did a great job of researching and providing what they could, any missing documentation was no fault of our staff. Rob Green (Place 3) asked, based on the mayor's question is there any potential liability to the city based on the incompleteness of the audit. Mr. Watson replied that these opinions do matter for credit ratings and grants could be potentially impacted which is why Brooks, Watson & Co. will begin auditing the fiscal year 2021-2022 as quickly as possible. Mayor Wilkerson asked Jack Clark based on his history advising the council on financial matters regarding the city, in his opinion, do we have a good product from this auditor. Jack Clark responded yes, absolutely.

## WORKSHOP

Mayor Wilkerson introduced the concept of smaller cities in Lampasas County entering an interlocal agreement with the county for management of subdivision developments in our ETJ. The city of Lometa has already entered into a similar agreement with Lampasas County.

Mayor Wilkerson stated the pros are:

- -not incurring the cost of having trained personnel to manage and enforce the ordinances that apply to our ETJ
- the county having a county attorney to consult, which would potentially free us from any legal litigation we could find ourselves in if we have an ordinance, we are trying to enforce that is in violation of that preemptive statute.

While a con would be:

-any fees associated with managing and enforcing ordinances would be paid to the county, not to the city.

Mayor Wilkerson expressed he wanted the council to have the opportunity to do some research, and when Joe England is available to do a presentation, he (mayor) would like to bring this back before the council in a future meeting for further discussion and to get a final decision. If the council has any questions preemptively, they can be sent to the city manager. Rebecca Ramos added that she has begun some research, being unfamiliar with this process, and she will consult with Mr. England for more information.

# City Manager's Report For the Period of September 13-26, 2023

# Honorable Council members and Mayor,

# During the timespan above, the following occurred:

#### MAINTENANCE UPDATES

1. A total of \$1,857.82 of un-budgeted funds were incurred for AC repair in the City Hall building. Repairs included the replacement of indoor coil, freon, and labor. This expense will be covered using the excess and unused funds in the Attorney Fees line item of the General Fund, Administrative Department.

# STAFF UPDATES

2. We offered the position of Municipal Court Clerk/Assistant City Secretary to Mrs. Keri McCoy. She accepted and will begin her employment with the City of Kempner on Thursday, September 28, 2023. Mrs. McCoy was one of the candidates that was selected and interviewed initially.

# CITY EVENTS/ ONGOING PROJECTS

- 1. On Wednesday, September 13<sup>th</sup>, 2023, I emailed each of you an update on the Altitude ISP Tower project. We are projected to have internet service in early October, with phones being added in late October. To ensure service to our citizens and stakeholders remain consistent, the transition over to this new internet and voice-over-internet provider (VOIP) phone's will be strategically coordinated.
- 2. At the direction of the mayor, DTP Construction was contacted and the previously purchased memorial stones were placed in the memorial wall located at Sylvia Tucker memorial park.

## TRAININGS & MEETINGS

 Chief Rodriguez and I attended the County Chief's meeting held at the Lampasas County Sheriff's Office, hosted by Texas Highway Patrol Sargeant, Ryan McKittrick. This meeting covered the 2024 Solar Eclipse and the probable effect it will have on the City of Kempner. Mayor Wilkerson asked that I attend in his place, as he had prior engagements that put him out of town during this meeting.
