AN ORDINANCE OF THE CITY OF KEMPNER, TEXAS PROVIDING FOR OFFICIAL BANK DEPOSITORY AND EXTENSION FOR ADOPTED BUDGET; FISCAL YEAR; CONSISTENT WITH STATE LAW; PROVIDING SEVERABILITY, OPEN MEETINGS AND EFFECTIVE DATE CLAUSES.

Whereas, the City of Kempner has designated First Texas Bank as a legal depository of all money belonging to the municipality, and all such money shall be deposited in said bank from time to time in the name of said municipality, said deposit not to be limited to a total sum of any amount.

Whereas, the fiscal year for the City of Kempner begins October 1st and ends September 30th, and

Whereas if the proposed budget of the new fiscal year has not been adopted before the new fiscal year begins, the adopted budget of the last fiscal year can be extended but not to exceed over ninety (90) days into the new fiscal year for normal operation and/or emergency finances until the proposed budget of the new fiscal year is adopted by majority vote of the city council.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KEMPNER, TEXAS, THAT:

- **Section 1.** Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.
- **Section 2.** <u>Severability.</u> If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.
- Section 3. <u>Effective date.</u> This ordinance shall take effect immediately from and after its passage and publication in the manner set forth with the provisions of the Local Gov't Code.

Section 4. Open Meetings. That it is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapt. 551, Loc. Gov't. Code.
