A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KEMPNER, TEXAS, CANVASSING THE ELECTION HELD ON MAY 1, 2021 BY CERTIFYING THE GENERAL ELECTION; AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE AND RELATED MATTERS.

WHEREAS, pursuant to the Contract for Elections between Lampasas County and of the City of KEMPNER, Texas and the General Election Notice Published on the City Website, a General Election was duly held on the 1st day of May, 2021, for the consideration of electing a Mayor and two (2) councilmembers for the City of KEMPNER, Texas;

WHEREAS, said election was held with the solemnities and formalities necessary to make it a valid election, all notices having been posted in the manner and for the length of time required by law:

WHEREAS, only duly qualified resident voters of the City of KEMPNER, Texas, voted at the General Election called and held on May 1, 2021;

WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11th) day after the General Election date for the purpose of canvassing the election results;

WHEREAS, section 67.004(a) of the Texas Election Code, as amended, establishes the quorum level required to canvass election results; and

WHEREAS, a quorum of the City Council serving as the Canvasing Authority met on Friday, May 7, 2021, and duly canvassed the election returns of the above-mentioned election and finds that the tabulation of the results of the election is correct, hereby attached as *Exhibit A*.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KEMPNER, TEXAS:

Section 1. The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

Section 2. That the City Council officially finds and determines a General Election was duly ordered to be held in the City of KEMPNER, Texas on the 1st day of May 2021 for the purpose of Resolution NO. E 21-05 #1

electing a Mayor and two (2) Councilmembers for the City of KEMPNER, Texas, and that proper notice of said election was duly given; that said election has been made and delivered by Lampasas County Elections Division; and that the City Council has duly canvassed said returns all in accordance with the Texas Election Code.

Section 3. That the City Council officially finds and determines that resident voters of the City of KEMPNER, Texas were allowed to vote at said election, and the following votes were cast at said election, and that the canvass of the votes cast in the said election and returns thereof, which is attached hereto as *Exhibit A*, were made in accordance to the Texas Election Code.

<u>Section 4.</u> Pursuant to the applicable provisions of the Texas Local Government Code, Texas Election Code, and the City of KEMPNER, Texas the City Council officially finds and determines and declares the results of said election reflects as following:
