

ORDINANCE NO. 1999-07-05-001

**AN ORDINANCE OF THE CITY OF KEMPNER, TEXAS, PROVIDING NAMES FOR STREETS, ROADWAYS AND ALLEYS WITHIN THE CORPORATE LIMITS OF THE CITY; AND PROVIDING SEVERABILITY, OPEN MEETINGS AND EFFECTIVE DATE CLAUSES.**

**Whereas**, the City of Kempner (the "City), Texas has numerous streets, roadways and alleys within the corporate limits of the City;

**Whereas**, the naming of all streets, roadways, and alleys will facilitate the avoidance of duplication of names, improve coherence of street numbering system and provide needed roadway designation to all roadways within the City limits; and

**Whereas**, the City having prepared a map of all known streets, roadways and alleys and the City Council, after accepting citizens comments and statements at an open public meeting, has determined names for all public and private streets, roadways and alleys within the corporate City limits.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KEMPNER, TEXAS, THAT:**

**Section 1. Findings.** The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.

**Section 2. Street Name Designation.** The City having prepared a map reflecting all known streets, roadways and alleys within the City limits, as more particularly shown on the map attached as Exhibit "A". All such streets, roadways and alleys shall hereafter be known by the designated name shown upon Exhibit "A" which is incorporated herein as if fully transcribed. All official City maps shall bear the names as designated upon the map attached hereto as Exhibit "A" and all signs placed upon such streets, roadways or alleys shall be identified accordingly.

**Section 3. Severability.** If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

**Section 4. Effective Date.** This ordinance shall take effect immediately from and after its passage.

**Section 5. Open Meetings.** That it is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the *Open Meetings Act*,


