# November Board of Directors' Meeting Summary

The Board approved three new members. The January 1st General Membership meeting, and the December 25th Tuesday 5-Stand will both be canceled due to the respective holidays. Chief Range Safety Officer Dave Reed will be scheduling RSO and Instructor classes after the first of the new year. Dates will be published as soon as they are known. Dave is also working on an addition to the S.O.P.s to address Club policy toward CCW holders who carry on the range. More to come as the policy is developed. Range Chair Jerry Hartman asked that the Club's policy on the Non Monetary Assessment (NMA) be clarified since some members don't appear to be fulfilling the requirements properly. This will become more important as we get into February and more members come to the Work Parties so they can renew their memberships. The complete NMA Policy will appear in the newsletter each of the next several months. The Christian High Trap Team has asked if it might be able to host a regional youth trap competition at the Club. The Board was receptive to the concept, and asked for more specifics as to number of shooters/teams, and a proposed date. The Board is also considering a follow-on activity for Women On Target participants to encourage them to continue their participation in shooting sports. Initially, we might host a few former WOT ladies at an event to be held within a month after their initial WOT shooting experience. Attendance would be limited so as not to impact other range activities. The Web Site Revision Committee reported that it has made considerable progress and expects to have a complete redesign within a couple months. Also included would be the ability to use the web site more effectively from a cell phone. Two additional security cameras have been installed.

# January General Meeting Canceled

Since the January General Meeting will fall on the 1<sup>st</sup>, the decision was made to cancel it.

### **Bulletin Calendar**

The Club is moving to a single calendar on the web for events and RSO scheduling. With that in mind, the December issue of the bulletin will be the last one with a calendar.

### NMA

We are coming up on that time of the year when you need to get your NMA done. Below is a summary of the requirements. For the work party, only the range chair can sign off. Do to some questionable activity in the past, the club will be verifying work part signatures this year. Invalid signatures could place your membership in jeopardy if you don't have time to complete the requirement.

In addition to any dues or fees as listed in the Policy Manual, every regular and senior member, as a non-monetary assessment, will be required to fulfill a participation requirement. To meet this participation requirement, the member must serve in a working capacity at the Club for a minimum of eight (8) hours at an official activity of the Club. Methods of meeting this requirement include:

Every regular and senior member will participate in a four (4) hour work party. Range Chair signature will denote completion of this requirement

Plus,

Every regular and senior member will be required to provide four (4) hours of volunteer service to the Club. Methods of completing this requirement include:

- 1. Participation in an additional four (4) hour work Party. Range Chair signature will denote completion of the requirement.
- 2. Working any four (4) hour event sponsored by the Club. Board of Director or Shoot Master signature will denote completion of this requirement.
- 3. Working as a Shoot Master at a scheduled event hosted by the Club.
- 4. RSO's completing 28 hours of service. RSO Coordinator signature will denote completion.

### **Fires and Shooting Restrictions**

CalFire has issued the restrictions of no fires or shooting on public lands because of the current drought. Legal hunting is the only exception.

# Removing Club Property From the Range

Club property may not be removed from the range without Board approval. This includes, but is not limited to replaced archery targets, broken trap machines, metallic targets, target stands, etc.

# **Reporting on Events**

All reports, documents, and proceeds concerning club events will be turned in to the Secretary within two (2) meetings, but in no case shall exceed forty-five (45) days from the date of the event. The documents pertaining to the event includes sign up sheets, comp tickets, etc. as required for reconciliation of funds. Nine people shot this match on November 18th. Targets were turkeys at 20 yards, a turkey swinger at 45 yards and a turkey swinger at 50 yards. Mike Steinmetz won the match, with Trent Alford second and Doug Ruff third.

# **RSO Reminder**

Leave the range in good condition when securing the range - trash dumped, old targets removed from down range, brass policed, etc.

### Situation at the Range?

Contact a board member if there are any situations that effect range operations. For example, a recent homicide investigation resulted in Sycuan Truck Trail being closed so there was no access to the range.

Other board members will be notified and action taken to notify members by mass email, web site notice or other methods as the situation dictates.

### **Range Flag Protocol**

A new procedure being implemented concerning the flags at the range:

Red – The range is hot.

Yellow – The range is cold and someone is working down range.

Please pay attention, especially to the yellow. Don't assume that someone just forgot to take it down!

The wording for the SOP revision is a work in progress but will be available soon.

### **Target Damage**

Another rifle range target has been damaged by use of inappropriate (wrong projectile, over-powered) ammo. See picture attached.

If you were shooting on the rifle range between noon Monday Sept. 24 and morning Saturday September 29 (excluding the Precision Long Rang Rifle match), please check your ammo.

Until further notice, ALL who would shoot any center fire ammo (rifle, handgun, shotgun) on the rifle range will be required to present their ammo to the RSO on duty for inspection, BEFORE firing any rounds. If you bring more than one box of ammo to shoot, each box must be inspected.

RSOs, if you have any question regarding any ammo presented for inspection, please ask the shooter to use a paper target or refrain from using the ammo in question on steel targets until that ammo can be deemed safe for our targets. If any shooter refuses to present all their ammo for inspection, ask them to leave the range immediately. Then call or text me.

The continued damage to Club property will not be tolerated. Additional incidents of damage will be reviewed by the Board and may result in restrictions on shooting or closure of the range.
