### **SOP Change to NMA**

S.O.P. addition (based on October 2019 vote by membership to allow N.M.A. completion by payment in lieu of work/participation):

Chapter 2 - Policy Manual

#### 4. Membership

G. Participation fulfillment and exceptions v. A member may opt to pay \$150.00 in lieu of working to satisfy the 8 hour participation requirement. The choice to pay must be made when a member submits their renewal paperwork during the renewal period of February 1 to April 30. The choice to pay is all or nothing – there is no partial payment to offset some portion of the requirement. A member may not opt out by payment at any other time during the year and, the Board will consider that member in violation of the non-monetary assessment requirement, and take appropriate action. New members must complete the non-monetary assessment during the first membership year in which they join the Club.

### Summary March 17, 2020 Board of Directors Meeting

The Board approved seven new members into the Club. Make it a point if you see/know them to welcome them into the Club. Member Ronnie Smith told the Board that he had received enough donations to go forward with the memorial plaque for long time members John and Wilma Schreuer. The Board has previously approved naming the utility building/ signup shack in their honor. Dedication will occur during the installation when it is rescheduled. The Board approved the annual request from Lakeside Sportsman's Club for a pallet of clavs. Elections have been postponed since the April Members meeting was cancelled. Most of the Board members up for election have agreed to continue for the next two years. However, Director Derek Alcarez and Vice President Lorrie Smith have expressed a desire for others to step up. So far, I have received interest in becoming a Director from only one member. Other places where members can volunteer to help include Installation Chair, Election Chair, and NRA Foundation Representative.

The Board spent considerable time discussing what the Club's response should be to the corona virus outbreak. In the end, the Board voted to temporarily, through April 30, ban non-members from Club property, to permit RSOs and Shoot masters the discretion of cancelling open shoot times and events, and to cancel the General Members meeting and elections. The Board also recognized that the outbreak has impacted members in their ability to satisfy the annual NMA requirement. To that end, the Board will allow members to renew who have not completed a work party but have performed at least 8 hours of service to the Club since May 1, 2019. Renewals must still be completed by April 30, 2020.

### Information on how the CCW licensing division has been affected by the COVID-19 policies

Remember, this is all in response to the COVID-19 outbreak and NOT intended to describe permanent changes. Once our public health situation normalizes, they will go back to business as usual. The situation has been further complicated because the outbreak happened at the same time they are implementing a new computer system to run the CCW application process. From the San Diego County Sheriff's Department: "All of this is very fluid with the current state of affairs. There may come a time where CCW Instructors may not be able to give the safety course. For initial applicants we will be able to extend the time frame for them to take the class but will not be able to issue the permit until the requirement has been fulfilled. The same would hold true for renewals, should their permit expire they will not be required to start over but we could not issue until the safety course is completed."

Questions:

#### Are you taking new CCW appointments?

We currently have suspended taking initial appointments while we are integrating the appointments we currently have on the books into our new online system. We have started contacting those with Initial appointments starting the last two weeks of March and after to download their application into Permitium. This is not open to the general public until April 1, 2020, each person we contact is given a one-time link to use. Beginning April 1st, the website will be available to the public. They will be able to go to our website and click on the link to submit their applications and make an appointment.

#### What do people do about renewals?

Right now renewals are still making appointments and coming into the office to be processed.

### What about people who had appointments in March and April?

As stated in the first response, we are contacting them to submit online with a one-time link, if we are unable to contact them, they should come into the office as scheduled.

#### Is licensing open for business?

Yes, we have posted a notice on our website, that we will not be doing any fingerprinting for the public at this time due to the COVID-19 outbreak and social distancing. If in doubt, please call Licensing at 858-974-2020. We are limiting the number of people in our lobby at any given time.

#### What do you want people to know?

Please do not come into our office if you don't have to, any questions call us and watch our website for updates. NOTE: The number for licensing is **858-974-2020** Please only call them if you absolutely must speak to someone. Please do not call the clerks or managers directly right now. They are too busy.

## 2020 Jim Kasten Memorial Cup



In honor of Jim Kasten we will be holding FOUR sporting clay matches in 2020. Two of the matches will be held at Maywood Rod & Gun Club, Perris California, and Two matches at Lemon Grove Rod & Gun Club, Alpine California. The winner of the Jim Kasten Perpetual Memorial Cup will be determined by the club winning the best of 4 matches and will be awarded at the conclusion of the final match on 14th June 2020. They are talking about banning all lead ammunition in indoor and outdoor ranges. Get your emails fired up!

Back in January we lost somebody that has lived here in San Diego all his life he was a big proponent of the 2<sup>nd</sup> Amendment. His name was Bob Maupin. Normally they're willing to take anybody willing to step up. But we don't make the decision.

Dave Reed spoke about the importance of having someone in this position to help change people's minds about the shooting sports and the importance of the programs like Shooting Sports camp and WOT. How it is important to reach out to the public to impact their opinion about the shooting sports.

CCW in San Diego. Who wants one and they can't have one? San Diego is approving a lot of people right now. People getting denied have a reason that they are getting denied. Right now, they have shut down the application process they are not bringing people in for interviews right now. This is a good thing. They are changing the way they are doing things. They are shutting it down for a week or two so they can get a much more streamlined process in place. It was taking 8, 9, 10, 12, 14 months to get in to get the interview. They've changed that. They're changing that so maybe it's going to be a month or two. Maybe three at the most so they can get people in there. When this started about a year and a half two years ago there were about 1000 CCW's in San Diego County. There are over 4000 now. I get calls every single day from people looking for classes because they just got approved. It's a very good thing. If you want one go and get it. The Sherriff of San Diego County is loosening things up and that's because of the work of gun organizations that are out there. If you want a CCW, apply. If you've thought about a CCW, apply. The more we get out there the more evidence is that bad things aren't happening with guns. The more we can show the Sherriff that the gun community is good people. Website to apply: San Diego County gun owners if you go to their website or you go to YouTube and look at their video. They have videos in place to tell you everything you need to do. They also have about 8 seminars around town that will walk you through the process. On their website they also have all the different justifications that it works. You still must have a justified statement, but they are very lenient with it now. They are going to do a background check on you. If you go to the San Diego Sheriffs website licensing division and you can download the application from there.

We have had several people talk about the Grants that we get. Phyllis, I know I'm springing this on you, but could you tell the members here the grants that we applied for and recently received but let them know what impact the program has for the members of the club. So, I usually write the grants and we receive ammo for WOT and we received a couple of firearms. We also received ammo for the Boy scouts, and I have to send one for the NRA Family Sports Camp we receive ammo for that as well. At its maximum when we had all those grants and wounded warriors the grants that we received exceeded \$20,000.00 They don't anymore. That's money that supports our outreach programs that we don't have to pull out of our pocket.

There are no tourniquets in our first aid kits. Do you know who Alan Coles is? Send him another email and tell him I sent you.
