# Summary October 20, 2020 Board of Directors Meeting

The Board accepted 7 new members into the Club. This brings the total new member count to 50 since we reopened in June. The Club still has plenty of openings, but the number is going down (a good thing!). The new (to us) office trailer will be arriving soon and may be here by the time the newsletter is published. The plan is to have it set reassembled to provide weather protection for the interior. We would like to start using it for meetings and will be working toward that goal in the next few months. For now, all meetings will be held at the range. General meetings will continue to start at 6:30 pm after the upcoming return to Standard Time (Sunday November 1).

Several members have volunteered to participate in the new Environmental Committee. Board Member Frank Valdez is the coordinator. While not a new policy, all Shootmasters are encouraged to clean up the ranges being used for their matches. Other Shootmasters and RSOs have had to do additional work lately to have safe range conditions. Remember, we have no employees. We are all volunteers and a clean range benefits all of us.

Another reminder to Shootmasters. Part of your job is to convey to the Board, as well as Club members in general, the success of your respective events. This includes timely (within 45 days according to the Club's By-Laws) reporting of attendance and revenue from the events. If you need a form to help you remember to do this, Contact Jerry Shiller for the form.

The Board approved an increase in the fees for all sporting clays events. The new fees, described elsewhere in this newsletter, go into effect starting in January 2021. The Board also approved an addition to the S.O.P.s regarding footwear on the ranges. Specific wording has not yet been approved, but the gist of the new policy is that flip flops, sandals, and other open-toed footwear will not be acceptable on the ranges.



### **Archery Shootmaster Needed**

Rod Richardson, one of the founders of LGRGC's field archery match has decided to retire as the Shootmaster. For the match to continue, we need another member to step up and take over for Rod. We still have many volunteers who help set up targets the Thursday before the match, and tear down/put away targets after the match is over. Contact Jerry Shiller or Rod Richardson.

#### Chief RSO Corner Dave Reed

Closed toed shoes are required on the firing line. Open toed shoes, flip-flops and/or sandals are a safety hazard on the firing line and shall not be allowed.

**RSOs and Shootmasters** - There have been reports of some events or open shooting sessions that did not clean up the range after they finished. It is the RSO and / or shootmasters responsibility to ensure all expended casings/ hulls no matter what material they are made of (brass, steel, aluminum, plastic) are picked up and either discarded or removed from the range prior to departing from the range. In addition, all targetry, props and/or aids for the event, including rifle racks and target stands, must be cleaned up and either discarded or returned to their original location as appropriate. Repeated failure to ensure this occurs may lead to suspension of your RSO privileges or future shooting events. We should all strive to follow the Boy Scouts "Leave No Trace" policy.


Interactions with RSOs or anyone enforcing safety rules. This month there was an isolated incident where a shooter was extremely disrespectful to someone enforcing basic firearms safety rules, that is not acceptable. I do not believe this is a widespread issue but it is one that needs to be addressed immediately. We are a private - all volunteer club that relies on our fellow members to ensure we all remain safe. We need to treat each other, and those who are giving up their time to ensure our safety, with the same decency and respect we would like to be treated with. Disrespecting those enforcing safety rules shows disrespect to the club and leads to a less safe shooting environment for all of us. As the Chief RSO I will immediately suspend the shooting privileges of any member who shows egregious disrespect to any RSO or other member who is attempting to enforce safety policies in accordance with the Standard Operating Procedures (SOP). If this happens you will be required to present yourself to the board in order to have your shooting privileges reinstated. This does not mean you cannot voice your opinion or argue your case, but you must keep it respectful, no cussing them out or calling them names because they are enforcing rules.

**RSO Authority** - RSOs have the authority to make decisions based on the club SOP and their good judgement. The RSOs decision is the final word during their shift. However, there have been several updates to the SOP and while we strive to keep all RSOs informed of the changes sometimes things are missed. If you believe the SOP allows what you are attempting to do you can always download the SOP on your phone and show it to the RSO to help them make an informed decision. This should resolve the issue in most cases. That being said, if the RSO is not comfortable with it based on the current situation they are empowered to make the call. Do not continue to argue with the RSO, comply with their requirements at the time and then call me to discuss the issue and I will work with you to either explain why the RSO made the decision they did or educate the RSO to ensure the SOP is followed going forward.

#### **Two-Man Rule**

Some maintenance is inherently dangerous due to the nature of the work. Activities being performed at the range such as those involving power tools, operating equipment, working at other than ground level or on electrical circuits, requires **two** (2) people to be present for safety reasons. The foregoing list is not meant to be all-inclusive and common sense should prevail as to what can be dangerous. It is the responsibility of each member to recognize those activities that, should an accident occur, a second person would be needed to summon help and administer first aid.

# **Reporting on Events**

All reports, documents, and proceeds concerning club events will be turned in to the Secretary within two (2) meetings, but in no case shall exceed forty-five (45) days from the date of the event. The documents pertaining to the event includes sign up sheets, comp tickets, etc. as required for reconciliation of funds.

## **Cash Turn-In**

The Secretary and Treasurer ask that cash being turned in either be consolidated to the fewest number of bills or, turn in a check.

For example, instead of turning in 20 one dollar bills, convert it to a single twenty dollar bill.
