Summary October 2019 Board of Directors Meeting

The Board approved three new members into the Club. Doug Norman, Chair of the Long-Range Planning and Environmental Committee, gave a short report summarizing several environmental issues, and then announced that he is retiring from the position. He will be missed. Chief Range Safety Officer Dave Reed has scheduled a RSO class for members on Sunday November 24, 2019. Any member who is not currently an NRA RSO certified should contact Dave to reserve a spot in the class. He has also tentatively scheduled a Basic Instructor class for Martin Luther King weekend next year. Dave has been very busy but has not forgotten that he still needs to offer some RSO Refresher sessions for the Club's existing RSOs.

The Board approved language for the S.O.P.s related to the one-year trial policy whereby members may pay \$150 in lieu of completing the 8-hour annual Non-Monetary Assessment (NMA). The Board also discussed the S.O.P. language related to what pistol ammunition may be fired at the Club's steel targets. More discussions are pending to clarify the issue. Board member Clyde Wilson investigated what would be required if the Club were to offer "Registered" sporting clays targets. The Board approved joining the National Sporting Clay Association as the first step toward that goal. Firearms donated to the Club by member Mike Borrelli have been moved to AO Sword in El Cajon, catalogued, and function checked for safety. By law, the guns may not be sold and DROSed before November 11. However, Club members can go to AO Sword to look at and prepurchase (requires money, not reserve, not lay-away) up to two of the firearms now. The public offering begins on November 11.

Kevin King reported on the 10th Annual Ginger Bass Shoot. A total of 26 shooters participated this year. The Club will be donating \$1500 to the East County Battered Women's Shelter this year. Jerry Vaughn said that repairs to the security camera system have been completed. The damage, caused by a near-lightning strike last month, cost \$2100 to repair.

Landscape Master Plan

The Club would like to update the LGRGC landscape master plan in preparation for a future presentation to the County of San Diego. If any member has experience with master plans and has the appropriate software that may be compatible with the County system, please let us know if you would be willing to help with this project. I understand that they will still accept drawings in Corel but prefer CAD. Please contact Lorrie Smith if you can help.

We wanted to let you all know that the color key on the left side of the calendar (see photo, what's circled in red) tells you on which range each event is taking place. The club rule is that when there is a scheduled event, other ranges are closed for this event unless otherwise noted, and we have several events that do allow shooting on other ranges during their event This color key will help you figure out what ranges are in use. Here's what they mean, from the top of the list to the bottom:

Teal Green-Archery

Green-Clubhouse

Purple-Entire Range-no open shooting

Yellow-Offsite Event

Black-Pistol Pit

Orange-Range Maintenance time (entire range closed)

Light Green-Rifle Range

Grey-RSO time (could be pit or rifle, and the RSO indicates that in his scheduled time)

Blue-Trap Fields

Red-Range Closed for Red Flag Warning

For those of you who are color blind, you can click on the event you're interested in, and in the box that comes up, under "calendar," it will say what range is in use for that event. S.O.P. addition (based on October 2019 vote by membership to allow N.M.A. completion by payment in lieu of work/participation):

Chapter 2 - Policy Manual

4. Membership

G. Participation fulfillment and exceptions v. A member may opt to pay \$150.00 in lieu of working to satisfy the 8 hour participation requirement. The choice to pay must be made when a member submits their renewal paperwork during the renewal period of February 1 to April 30. The choice to pay is all or nothing – there is no partial payment to offset some portion of the requirement. A member may not opt out by payment at any other time during the year and, the Board will consider that member in violation of the non-monetary assessment requirement, and take appropriate action. New members must complete the non-monetary assessment during the first membership year in which they join the Club.

All items offered for sale must be sold in accordance with federal, state and local laws.

Every month the club members can buy up to two guns. The only way for you to express your interest is to come to see the guns at the shop. If you want additional guns you have to wait a month and see if the gun is still there. We will keep a list. AO Schwartz firearms in El Cajon. The last thing, if the guns go unsold, they will be on sale to the public and we will keep marking the guns down.

Unfinished Business:

Mark Hopewell is taking over the organization for the NRA Shooting Sports camp in December 21st a Saturday. You will be hearing more about that and Mark will need a whole bunch of Volunteers to make that day run smoothly. We need Mentors. RSO's. Parking guides. Someone checking to see that the public doesn't bring firearms in. This is a day about shooting and fun with shooting the different disciplines. This event is not about politics. Things that we typically run out of faster is handgun ammunition. We will have an air gun setup also. The club has received a grant from two years ago. We have a decent supply of ammunition. Worst case we limit how many rounds a participant can shoot.

The Board has ok'd a proposal to give members the option to pay \$150.00 in lieu of the NMA for the club. This is to be voted on by members of the club. Lorrie Smith spoke about the proposal. It's got to be done at the time you pay the membership dues. The proposal is for a one-year trial period. It is an option. The whole concept is there are a lot of potential members who would not want to do NMA, but we could use their dues and buyout for the club's benefit. We are talking about next year. It is all or nothing. You must buy out at the beginning of the year. This is above and beyond the regular dues to the club. At the end of the trial period we may want to up the amount. I doubt it would go down. Even though the board could institute it we thought we would bring it to the membership. At this point if there was a change, we would not be able to vote on it till November. Maybe we need to change it and the people can pay at the last minute. The Board decided that they didn't want to put all the extra work on the Membership chairman. That is why the proposal is written like it is. There is a waiver policy if you have trouble doing the work parties if you come before the board. A valid request has not been denied. The tally yes 37 no 22. The vote was taken, and the proposal passed by a majority. We will make it a part of the renewal packet.

East County Friends of the NRA banquet: In addition to our table guns we won two other guns a Smith and Wesson compact revolver in 357 magnum. There is a Kimber custom 2 in 45 ACP. And a Mossberg 500 shotgun package for Deer Hunting and turkey hunting and a cheesy piece of artwork. We were the only ones that purchased a table this year.
