

TERMS & CONDITIONS

- 1. Dance Tournament
- 1.1 **Pearl Ball ProAm Dance Tournament** is the event organized by Capital Dance Center and BallroomPages, that is being held on 23&24 of March 2024 at Saadiyat Rotana Resort & Villas in Abu Dhabi, United Arab Emirates. It is open for dance couples that consist of a Teacher (Professional) and a Student (Amateur).
- 1.2 Pearl Ball Tournament is inclusive of the following elements:
- Training Camp (dress code: training attire)
- Tournament Day (dress code: unique business chic)
- Welcome Reception (dress code: cocktail, total white)
- Gala Dinner (dress code: dress to impress evening attire)
- 2. Dance Styles

Pearl Ball Tournament will run in the following dance styles and dances:

- International Standard (Slow Waltz, Tango, Viennese Waltz, Slow Foxtrot, Quickstep)
- International Latin (Cha-Cha, Samba, Rumba, Pasodoble, Jive)
- American Smooth (Walts, Tango, Foxtrot, Viennese Waltz)
- American Rhythm (Cha-Cha, Rumba, Swing, Bolero, Mambo)
- Argentine Tango Salon (Tango, Vals, Milonga)
- Argentine Tango Freestyle (Tango, Vals, Milonga)
- Caribbean Mix (Bachata, Salsa, Merengue, Cha-cha-cha,)
- 3 Dance Events
- 3.1 Participants can compete in following dance events: Single Dance, Multi Dance Championship, Rising Star Scholarship, Scholarship, Arabian Gulf Cup, DANCE VISION WORLD CUP PROAM SHOWCASE CHAMPIONSHIP, VIP SHOWCASE.
- 3.2 In Single Dance event results will be based on the performance of each dance in comparison to other competitors; in any other dance events results will be reflecting collectively on the performance of all the dances in comparison to other competitors.
- 3.3 To participate in any Scholarship event competitor must enter the same amount of dances in Single Dance events per every Scholarship is intended to enter.
- 3.4 For DANCE VISION WORLD CUP PROAM SHOWCASE CHAMPIONSHIP event participant can choose any of dance styles and dances presented at Pearl Ball Tournament and mentioned in this Terms & Conditions. The duration of the performance should not exceed 3

minutes in total from entering the dance floor up to exiting it. Music will be faded after 3 minutes is over.

- 3.5 VIP SHOWCASE is a non-compete division and will be presented at Gala Dinner.
- 4. Syllabus, Level and Categories
- 4.1 All the dance material used should be based upon the Dance Vision syllabus. For more details please follow *https://dancevision.com*.
- 4.2 Pearl Ball Tournament will be held in following Levels and Categories
- **Newcomers** (Closed)
- Bronze Intermediate (Closed, Open)
- Bronze Full (Closed, Open)
- Silver Intermediate (Closed, Open)
- Silver Full (Closed, Open)
- Gold Intermediate (Closed, Open)
- Gold Full (Closed, Open)
- Gold Star (Closed, Open)
- 4.3 During Closed Category the figures that are used should be in strict accordance with the syllabus; during Open Category there will be no restrictions in regards to the use of the dancing figures. Lifts are not permitted at any Level or Category with the exception of DANCE VISION WORLD CUP PROAM SHOWCASE CHAMPIONSHIP and VIP SHOWCASE events.
- 5. Age Groups
- 5.1 The Age Group is defined by the age of the Student (Amateur). It is allowed to enter one additional younger Age Group at any of dance events.
- 5.2 Single Dance and Multi Dance Championship events are held in following Age Groups: A0 (under 18), A1(19-35), A2(36-50), B1(51-60), B2(61-70), C1(71-80), C2 (above 81)
- 5.3 Rising Star Scholarship and Scholarship events will be held in following Age Groups: **Teen (under 18)**, **A(19-35)**, **B(36-50)**, **C(51-60)**, **D(over 61)**. Argentine Tango and Caribbean Mix Scholarships will be combining all the Age Groups.
- 5.4 Arabian Gulf Cup event will be held in following Age Groups: **A(19-35)**, **B(36-50)**, **C(over 51)**. Arabian Gulf Cup in Argentine Tango and Caribbean Mix will be combining all the Age Groups.
- 6. Registration Fees

All the Registration Fees including Packages, Tickets and Dance Entries should be submitted and payed in full in advance prior to the competition deadline. Pearl Ball Tournament Registration Deadline is 15 March 2024. The organizers has a right to deny the late registration. Acceptance of

such a registration might be possible, however the Late Registration Fee of 500USD will be applied.

7. Cancellation Policy

Refunds for Packages and Dance Entries will be given if notified by **24 February 2024**. Processing fee of 8,6% will be deducted from the total amount.

Any cancelation after 24 February 2024 will be a subject to 50% Refund or 70% Credit towards Pearl Ball Tournament 2023 from total amount.

If cancelation is of Packages and Dance Entries occurred after **14 March 2024** there will be no refund available, however 50% Credit towards Pearl Ball Tournament 2023 will be offered from total amount paid.

Cancelled dance entries on the day of event will not be a subject for a refund.

Any tickets purchased A La Carte (Competition Entry Ticket, Welcome Party, Gala Dinner) are not refundable, all sales are final.

All the Packages, Dance Entries, Tickets will be fully refunded if the event is cancelled by organizers.

- 8. Waiver of Liability
- 8.1 All persons attending Pearl Ball Tournament (participants, officials, guests or audience) agree to be personally responsible for their own safety and actions during the event.
- 8.2 All attendees agree to comply with all Pearl Ball Tournament policies, rules and regulation, including but not limited to all Pearl Ball Tournament policies, guidelines, signage, and instructions.
- 8.3 With full awareness and appreciation of the risks involved, Attendees, on behalf of yourself and on behalf of their family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue Pearl Ball Tournament, Capital Dance Center or BallroomPages, its board members, officers, agents, servants, independent contractors, affiliates, employees, successors, and assigns (collectively the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me related to COVID-19 whether caused by the negligence of the Released Parties, any third-party associated with Pearl Ball Tournament, or otherwise, while participating in any activity while in, on, or around the Pearl Ball Tournament and/ or while using any Pearl Ball Tournament facilities, tools, equipment, or materials.
- 8.4 All Attendees by participating at Pearl Ball Tournament acknowledge that they have read the foregoing Waiver of Liability, understand voluntarily as their own free act and deed, including

without limitation the Release of Liability and Indemnification requirements contained in this document; all attendees sufficiently informed about the risks involved in attending the Pearl Ball Tournament.

8.5 All attendees agree that this Wavier of Liability shall be governed by and construed in accordance with Abu Dhabi law in United Arab Emirates, and that if any of the provisions hereof are found to be unenforceable, the remainder shall be enforced as fully as possible and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the Wavier of Liability as a whole.
