Duration: November 1– March 31

Requirements include:

- Up-to-date WA State Registration and Insurance (500K liability)
- Pre-pay in full or first month initial payment with ACH enrollment
- 15 days advance notice of launch/departure/early termination
- Pre-termination in place to ensure launch by 3/31/26
- Daily rate would kick-in for vessels not vacated by 3/31/26

Rules/Restrictions include:

- Customer account must be in good standing
- No proration, no converting to storage location mid-month, if converting – agreement must be effective the 1st
