The physical activities, including running, climbing, and hiking over rugged terrain, conducted day and night, may cause slipping or falling. Waterfront activities conducted in lakes and rivers carry the risk of drowning. Environmental risks and hazards include rapidly moving, deep or cold water; insects, snakes, and predators, including large animals; falling and rolling rock; lightning, fire, smoke, flash floods, and falling timber; and unpredictable forces of nature, including weather, which may change to extreme conditions without notice. Activities may occur in remote places, away from medical facilities, where communication and transportation are difficult. Equipment may fail or malfunction despite reasonable maintenance and use. Transportation to and from class destinations is in a properly equipped van or personal vehicle.
