The parties choose the above stated addresses as their physical addresses at which legal proceedings may be instituted.

Whereas the "client" wishes to engage with " Doggo's off leash ", "Doggo's off leash" agrees to undertake the services under the terms and provisions defined in this Contract as well as the "clients" Information sheet(s) doggo Information sheet(s), the Veterinary Release Form(s), In home visit/sitting form(s), transport form(s), and key release form(s) and or requests/agreements made, pet sitter dashboard, pet owner dashboard, specified in writing (text , facebook messenger, instagram etc.) which shall all become part of this Contract. Any reference to dogs or pets in this contract shall refer to those specified on the doggo Information sheet(s)/ pet owner dashboard.

## **1. Relationship and Responsibilities**

1.1. It is expressly understood that the "client" retains the services of "Doggo's off leash" as an Independent Contractor/ self employed and not as an employee.

1.2. "Doggo's off leash" undertakes to perform the agreed-on services in an attentive, reliable and caring manner and the "client" undertakes to provide all necessary information to assist in this performance.

1.3. "Doggo's off leash" undertakes to notify the "client" of any occurrence pertaining to the dog which may be relevant to the care and well-being of the dog.

1.4. "Doggo's off leash" will supply and be equipped with waste bags and will duly remove the dog's faeces from all public places.

1.5. "Doggo's off leash" reserves the right to walk other compatible/ prior assessed dogs at the same time and undertakes to limit the number of dogs walked with one person to 5-10 Doggo's maximum per adventure.

1.6. "Doggo's Off Leash" reserves the right to take photos of the doggos signed up within this agreement and use them on all public platforms such as websites/ google and all social media.

1.7. "Doggo's off leash" shall not be obliged to perform any other duties except those specified on the "clients" Information sheet and Pet Information sheet. And or duties arranged prior.

1.8 "The client" agrees to make sure their Doggo has been feed atleast 1 hour "prior" to being collected by "Doggo's Off leash" (To prevent bloat "life threatening), if you are unaware what this is please ask your vet to explain.

1.9 The Client agrees to provide all possible information about their dog to "Doggo's Off Leash", the "Client" also agrees to NOT lie about the behaviour traits/personaility of their dog.

1.10 "The client" agrees to consistently keep up with council registrations/ worming and fleaing/ Vaccinations and all related responsibilities/requirements to owning a dog in NZ during this agreement.

## **2. Compensation**

2.1. "Doggo's off leash" will be paid the amount in "**total**" for the services requested within 24 hours of booking via pet owner dashboard, this includes being cleared via our bank account- **03-1585-0113039-004** or stripe via pet owner dashboard. If your request has not been paid within 24 hours of booking, your request will not be reserved meaning could be filled by another customer, 50% of the booking will be held as a non refundable deposit, this is to prevent the business losing revenue and preventing last minute cancellations/change of mind.

2.2. No payment -**no service.** (Firm).

#### **4. Cancellation or Early Termination**

1. Either party may terminate this Dog Walking Contract with at least 2 weeks notice, this gives us time to fill your Doggo's spot we have kept open for however long they have been with us.
- 4.2. Cancellation by the "client" of Booked appointments with less than 12 hrs notice will be charged at the full rate or rescheduled at the discretion of "Doggo's off leash"(availability depending) within that week period only (Monday-Sunday). Payments must be paid in full within 24 hours of your confirmation email via (pet owner dashboard), Your booking will not be reserved unless paid in full within the time frame stated above, we accept proof of purchase screen shots also. 50% of the full payment required on booking is a non refundable deposit, to prevent the business losing revenue and to also prevent last minute cancellation/change of mind.
- No 4.3. Where "Doggo's off leash" as sole proprietor needs to cancel a scheduled walk due to unforeseen circumstances, he/she may appoint a substitute Walker with the written approval of the "client" and any difference in the fees charged shall be for the account of "Doggo's off leash".
- 4.4. Should any dog become aggressive/dangerous or show early signs of these behaviours "Doggo's off leash" has the right to terminate this contract with immediate effect.

#### **5. Liability**

- 5.1. "Doggo's off leash" accepts no liability for any breach of security or loss of or damage to the Owner's property if any other person has or hasn't, access to the property during the term of this agreement and or if a break in was to occur.
- 5.2. "Doggo's off leash" shall not be liable for any mishap of whatsoever nature which may befall the "clients" dog or caused by a dog who has unsupervised access to the outdoors.
- 5.3. The "client" shall be liable for all medical expenses and damages resulting in an injury to "doggo's off leash" caused by the "Clients" dog as well as damage to the "clients" property, and or damage/injury to another dog, or the clients dog itself.
- 5.4. "Doggo's off leash" is released from all liability/ costs related to transporting dog(s) to and from any veterinary clinic or kennel, the medical treatment of the dog(s) and the expense thereof.
- 5.5 "Doggo's Off Leash is released from all liability of lost items such as collars, collar tags, harnesses, keys, and so on.

#### **6. Emergencies**

In the event of an emergency, "Doggo's off leash" shall contact the "client" at the numbers provided to confirm the "clients" choice of action. If the "client" cannot be reached timeously, "Doggo's off leash" is authorized to:

- 6.1. Transport the dog(s) to the listed veterinarian;
- 6.2. Request on-site treatment from a veterinarian;
- 6.3. Transport the dog(s) to an emergency clinic if the previous two options are not feasible.

#### **7. Security**

"Doggo's off leash" is not liable or responsible for break ins to the clients property by any other person, client details and information provided is to be kept confidential within the "Doggo's off Leash" business.

#### **8. Relaxation of Terms**

No relaxation, indulgence, waiver or release by any party of any of the rights in terms of this agreement on one occasion shall prevent the subsequent enforcement of such rights and shall not be deemed to be a waiver of any subsequent breach of any of the terms.

#### **9. Whole Agreement**

This Contract and "client" Information sheet(s) , doggo Information sheet(s), the Veterinary Release Form(s), In home visit/sitter form(s) and transportation form(s), pet sitter dashboard, pet owner dashboard, attached constitute the sole and entire agreement between the parties with regard to the subject matter hereof and the parties waive the right to rely on any alleged expressed or implied provision not contained therein. Any alteration to this agreement must be in writing and signed by both parties.

#### **10. Assignment**

No party may assign any of its rights or delegate or assign any of its obligations in terms of this Contract without the prior written consent of the other party, except where otherwise stated.

#### **11. Binding Effect**

The terms of this Contract shall be binding upon and accrue to the benefit and be enforceable by either party's successors, legal representatives and assigns.
