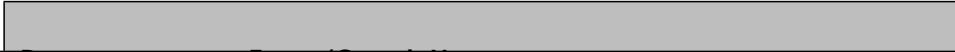

SSJFA will asses and administrative fee of 50% on any registration refund requested after issuing equipment; refunds will only be provided in the form of a voucher based on a criteria set by the Executive Committee. No refund vouchers will be given after games begin and no refund vouchers will be issued until all equipment is returned. SSJFA requires a physical for each child participating in tackle football, flagfootball, and cheerleading. No player shall participate or play any league games prior to submitting a copy of a current physical on file with the league.

Rules and Regulations: I willing agree to comply with the program's stated and customary terms and conditions for participation. I will furnish an **Original Certified Birth Certificate** and copy of school transcript of the above named applicant to SSJFA. I give permission to SSJFA to validate above named applicant school grade with the school listed. I agree as parent/legal guardian of said applicant, understand it is the responsibility of the parent, applicant, team and Association to comply with any and all Rules and Regulations of SSJFA. Any noncompliance with said Rules and Regulations shall be cause for disciplinary action to be taken against said applicants, parent or team by SSJFA.
