Hello Hamlet Board, Friends and Neighbors!

After 46 years in health care service and education, I am retiring.

When Perry and I return in April 2025, my CPR/St. John's First Aid will expire. I will not renew.

The AED Committee is a much needed service at GSA and truly, it has been my privilege to serve and assist. The AED protocols and practices have changed since my start in 2014 at GSA. Times and events have required change and the committee addressed this.

We are still the "talk" of SUMA with our AED fridge magnets and the procedure of sending an escort vehicle to the Market corner to assist the EMS team to the needed location.

Adding in the "PAD" protocol in which our AED is registered provincially and federally as is so many other AED's, this means that a 911 operator can direct the caller to the nearest AED. Imagine, you are at a beach in Alberta, a cardiac event occurs, you call 911 and the operator says the AED is just behind you at the beach store..wow. The new statistic in a cardiac event is that if CPR is initiated and an AED is attached, there is a 75% rate of survival!! This stat is huge for the residents and visitors at GSA when medical assistance is at least 32 kilometers away.

I will leave a Task list with Deb Schmidt along with one of the information binders and my keys.
