- a) Finance –RM financial report reviewed. General discussion on if we should anticipate an increase from the RM Good Lake #274. Budget meeting of board to be scheduled last week of March.
- b) Transfer & Maintenance Dale C has worked on keeping the site clear. Transfer site road has been graded by the RM extending the wings to push more snow off the snow surface, With the thaw freeze cycle we anticipate the annual soft spots but appears to be in good seasonal order.
- c) Lights and lagoon The lagoon road has been plowed by the RM. No Hamlet lights have been reported as defective.

- d) Roads and water- The RM grader has plowed and graded Capalano to corner of Heritage. The grader does not have the blade lift capacity to not close off driveways. The grading done, has pushed snow back further into the ditches. With the seasonal thaw freeze cycle we will experience ice and ruts on the road ways. The slow thaw cycle is assisting us with small amounts of water versus an abundance. A question was brought forward about the cat tails. Access is limited by contractors to some areas. Permission for equipment can be granted to Hamlet property, however access may be restricted by trees on adjacent property. Further discussion will take place on this matter with the contractor.

- f) RM representative- extensive report on roads ,grading, higher than normal costs on gravel. RM deep in budget discussions.
